American Osteopathic Association;

HRS § 453-8(a)(11): Revocation, suspension, or other disciplinary

action by another state or federal agency of a license, certificate, or medical privilege for reasons as provided in this section; and

HRS § 436B-19(12): Failure to comply, observe, or adhere to any

law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license.
