Edward M. Andujar, M.D.

After due consideration of the information received as well as Dr. Andujar's oral testimony, it was moved by Chair Takanishi, seconded by Dr. Bintliff and unanimously carried to deny Dr. Andujar's application for medical licensure, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Andujar's application:

- HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;
- HRS § 453-8(a)(8): Incompetence or multiple instances of negligence, including but not limited to the consistent use of medical service, which is inappropriate or unnecessary;
- HRS § 453-8(a)(9): Conduct or practice contrary to the recognized standards of ethics for the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Osteopathic Physicians and Surgeons, or the American Osteopathic Association;
- HRS § 453-8(a)(11): Revocation, suspension, or other disciplinary action by another state or federal agency of a license, certificate, or medical privilege for reasons as provided in this section;

- HRS § 453-8(a)(12): Conviction, whether by nolo contendere or otherwise, of a penal offense substantially related to the qualifications, functions, or duties of a physician or osteopathic physician, notwithstanding any statutory provision to the contrary;
- HRS § 436B-19(8): Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity; and
- HRS § 436B-19(12): Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license.

Valerie Gironda, M.D.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Dr. Akaka and unanimously carried to deny Dr. Gironda's application for medical licensure, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Gironda's application:

- HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;
- HRS § 453-8(a)(8): Incompetence or multiple instances of negligence, including but not limited to the consistent use of medical service, which is inappropriate or unnecessary;
- HRS § 453-8(a)(9): Conduct or practice contrary to recognized standards of the ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association; and
- HRS § 453-8(a)(15): Submitting to or filing with the board any notice, statement, or other document required under this chapter, which is false or untrue or

contains any material misstatement or omission of fact.

Edgar K. Oliveira-Filho, M.D.

After due consideration of the information received, it was moved by Dr. Desai, seconded by Chair Takanishi and unanimously carried to deny Dr. Oliveira-Filho's application for medical licensure, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Oliveira-Filho's application:

- HRS § 453-8(a)(6): Procuring a license through fraud, misrepresentation, or deceit, or knowingly permitting an unlicensed person to perform activities requiring a license;
- HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;
- HRS § 453-8(a)(9): Conduct or practice contrary to the recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;
- HRS § 453-8(a)(11): Revocation, suspension, or other disciplinary action by another state or federal agency of a license certification or medical privilege for reasons as provided in this section;
- HRS § 453-8(a)(15): Submitting to or filing with the board any notice, statement, or other document required under this chapter, which is false or untrue or contains any material misstatement or omission of fact;
- HRS § 436B-19(8): Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity; and

HRS § 436B-19(12): Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license.

Clarence B. Steels, M.D.

After due consideration of the information received, it was moved by Dr. Desai, seconded by Dr. Sept and unanimously carried to approve Dr. Steels' application for medical licensure and issue him a Non-Disciplinary Letter of Education due to his failure to provide accurate information on his application. Additionally, the Board requires that Dr. Steels submit a revised application.

Mona Tomescu, M.D.

After due consideration of the information received, it was moved by Dr. Bintliff, seconded by Dr. Akaka and unanimously carried to approve Dr. Tomescu's application for medical licensure and issue her a Non-Disciplinary Letter of Education due to her failure to provide accurate information on her application. Additionally, the Board requires that Dr. Tomescu submit a revised application.

Request for  
Reconsideration:

R. Bryan Klassen, M.D.

After due consideration of Dr. Klassen's request for reconsideration dated May 8, 2014, it was moved by Dr. Desai, seconded by Dr. Bintliff and unanimously carried to deny Dr. Klassen's request for reconsideration.

New Business:

a. Administrative Process for Requests for Reconsideration

Executive Officer Quiogue indicated the Board would need to consider two separate parts to this agenda item: 1) whether it would continue to entertain such requests; and 2) whether the Board would give a denied applicant for whom the Board considered a request for reconsideration, and subsequently denied that request for reconsideration, a contested case hearing on the denial of the request for reconsideration.

In consideration of part 1 of the agenda item, members generally discussed the pros and cons of entertaining such requests.



Members inquired whether a request for reconsideration ever resulted in the Board issuing a license/certificate after the denial of an application.

Chair Takanishi indicated that over the tenure of his appointment, the Board, after reviewing a request for reconsideration and substantive new information, had issued a temporary medical license to an individual.

Dr. Chun indicated that she was inclined to continue with the Board's established process regarding requests for reconsideration. In other words, the Board would continue to entertain such requests on a case-by-case basis, and consider whether to grant or deny a request based upon each individual applicant's situation and request.

With regards to part 2 of the agenda item, members reviewed: a request for a contested case hearing made by Rosemarie Toussaint, M.D. on the denial of her request for reconsideration; and the Hearings Officer's Findings of Fact, Conclusions of Law, and Recommended Order Granting Respondent's Motion to Dismiss, which the Board adopted as its Final Order ("Order") on February 13, 2014, in "In the Matter of the Application for a Medical License of Claudia R., Mondragon, D.O., Petitioner; MED-LIC- 2013-005". In general, the Hearings Officer determined that because a contested case over the denial of a request for reconsideration is not required by law, the denial of such request does not create a "contested case" for the purpose of judicial review under HRS §91-14.

Chair Takanishi indicated that for the Board to be consistent with its Final Order in the Mondragon case, the Board would not give an individual whose request for reconsideration was denied a contested case hearing.

Discussion followed. It was moved by Chair Takanishi, seconded by Dr. Desai and unanimously carried to: 1) not grant Dr. Toussaint's request for an administrative hearing in the denial of her request for reconsideration; and 2) continue to entertain requests for reconsideration on an individual basis.

Chairperson's  
Report:

Chair Takanishi recognized the importance of the Board's role in reviewing applications, and determining whether an applicant: 1) meets the minimum licensing requirements; and 2) whether these applicants are safe and competent to practice in this State. Chair Takanishi referred to an earlier concern made by a member regarding applications submitted for MDR or DOSR licenses. Chair Takanishi indicated that because a majority of these applicants for MDR/DOSR applications begin residency training on/about July 1 of every year, it would be detrimental to their training if they were not able to begin training as scheduled. Some consequences of not having their MDR or DOSR licenses approved by the start date of their residency training include placing future board certification in jeopardy, etc.

Drs. Desai and Bintliff indicated that if the residency programs are in full support of these types of applications, then the Board should consider (provided that there is no substantive derogatory information) delegating to staff the authority to approve such applications.

DAG Wong stated that in order for the Board to consider certain delegations, those delegations must be in accordance with HRS § 436B-8. She stated further that delegations must be ministerial in nature, and should not require staff to exercise its expertise and discretion.

Executive Officer Quiogue asked members for examples of what they would consider non-substantive derogatory information. She indicated that several of the MDR/DOSR applications reviewed by the Board today disclosed matters such as the resident being issued an academic notice or warning, being placed on a remediation plan, etc.

Chair Takanishi stated from an academic perspective, and in his role as program director for a residency program, that academic notices or warnings and being placed on a remediation plan are not necessarily in and of themselves considered a "substantive derogatory" issue. However, sometimes an applicant does not heed the notice or warning. Or sometimes the applicant on a remediation plan does not successfully remediate. In these situations, the notice, warning, or remediation plan may lead to more complex issues that are ultimately substantively derogatory.

Executive Officer Quiogue stated she would bring an application to the Board for its consideration if there were circumstances that

required the exercise of her discretion. If she felt uncomfortable about ministerially carrying out the Board's delegation, she would bring the application to the Board.

Chair Takanishi went on to say that, in his opinion, substantive derogatory information includes disclosures of probation, suspension, and termination from the residency program.

After thoughtful discussion, it was moved by Dr. Desai, seconded by Dr. Akaka, and unanimously carried to delegate to the Executive Officer, in accordance with HRS §436B-8, the authority to review and issue licenses to MDR/DOSR applicants whose records and files do not include substantive derogatory information such as probation, suspension, or termination from the residency program. Applicants with probation, suspension, or termination from a residency program shall be brought to the Board.

Applications requiring the exercise of staff's discretion shall also be brought to the Board.

Applicants who only have notices, warnings, or a remediation plan and have successfully heeded the warning, or are currently satisfying all terms of remediation or successfully completed remediation, may be approved by Board staff.

Chair Takanishi extended his heart felt mahalo and aloha to members and Board staff for their hard work.

Members and Board staff expressed their thanks to Chair Takanishi for his commitment to public service, and wished him the best of luck and success in all his future endeavors.

Adjournment: It was moved by Dr. Sept, seconded by Mr. Puletasi, and unanimously carried to adjourn the meeting at 3:27 p.m.
