Call to Order: The meeting was called to order at 1:00 p.m. at which time quorum was established.

New Business:

- a. Licensing Enforcement Administration Project (LEAP):
Presentation by Keali'i Lopez, Director, Department of
Commerce and Consumer Affairs.

Jo Ann Takeuchi, Deputy Director, DCCA, appeared before the Board to discuss the Licensing Enforcement Administration Project ("LEAP").

Ms. Takeuchi expressed her sincere gratitude to members for their service to both DCCA and the consumers of this State.

Ms. Takeuchi informed the Board that since 1982, the PVLD has used the same computer database to record relevant information regarding applicants and licensees. She indicated that DCCA had been tasked with looking at innovative ways to license and enforce relevant laws and/rules.

Ms. Takeuchi informed the Board that there are four (4) targeted goals for the project, which include:

1. Timely and effective licensing
2. Transparency/outreach to both licensees and consumers
3. Provide necessary resources, which may include the use of Smart Cloud technology
4. Statutory and rule changes

Ms. Takeuchi asked for the Board's participation and leadership with this project. She went on to say that any deliberative or policy changes are to be board driven.

Dr. Desai asked how long the project is anticipated to last and the length of time it would take to make all of the suggested improvements, including database/hardware upgrades.

Ms. Takeuchi responded that she anticipates that changes will be made immediately. She informed members that she hopes to schedule meetings with board chairs prior to their August 2014 meetings. She indicated further that DCCA is already in the process of speaking with vendors regarding upgrades to its databases.

Dr. Desai thanked Ms. Takeuchi for her presentation. Ms. Takeuchi, Ms. Suzuki, Ms. Cabral, and Mr. Suyama left the meeting room at 1:18 p.m.

It was moved by Dr. Akaka, seconded by Dr. Holt, with Dr. Chun recusing herself, and carried by a majority to approve Dr. Freese's application for medical licensure.

Scottie A. Bussell, M.D.

After due consideration of the information received, it was moved by Dr. Desai, seconded by Dr. Sept and unanimously carried to approve Dr. Bussell's application for medical licensure subject to certain conditions, basing its decision on the following grounds of the Hawaii Revised Statutes (“HRS”), which find support in the records and files of Dr. Bussell's application:

HRS § 436B-19(4): Practicing the licensed profession or vocation while impaired by alcohol, drugs, physical disability, or mental instability; and

HRS § 436B-19(9): Conduct or practice contrary to recognized standards of ethics for the licensed profession or vocation.

Based on the foregoing, the Board hereby imposes the following conditions to Dr. Bussell's conditional license:

1. Dr. Bussell's conditional license shall remain conditioned for at least two (2) years.
2. During the period of Dr. Bussell's conditional license, he shall have his treating psychologist and/or psychiatrist submit to the Board quarterly written reports. These written reports shall include, but not be limited to: 1) Dr. Bussell's compliance with the treatment plan established by his treating psychologist and/or psychiatrist; and 2) Dr. Bussell's ability to safely practice medicine in all settings.
3. Dr. Bussell shall notify the Board in writing at least ten (10) days prior to the start of practicing medicine in the state of Hawaii.
4. Dr. Bussell shall notify the Board in writing quarterly of the following information:
 - a. The physical and mailing address of his practice location;
 - b. The type of practice setting (e.g. private practice, group practice, etc.);
 - c. The scope of his medical practice;
 - d. A list of hospitals and its address in which he is credentialed and/or privileged during the period of his conditioned license.
5. At the time Dr. Bussell begins practicing medicine in Hawaii, he shall, at his sole expense, be evaluated and enter into a monitoring contract with Pu`ulu Lapa`au, Hawaii Program for Healthcare Professionals ("Pu`ulu Lapa`au"). The length of the monitoring contract shall be determined by Pu`ulu Lapa`au. However, said contract may be extended by the Board if the Board believes that reasonable grounds exist.

6. If at any time Pu`ulu Lapa`au determines that Dr. Bussell is not in compliance with the monitoring contract, Dr. Bussell shall immediately notify the Board and immediately cease practicing medicine until Pu`ulu Lapa`au specifies to the Board what conditions, if any, it recommends for Dr. Bussell to safely resume the practice of medicine. Depending upon Pu`ulu Lapa`au's written report and recommendations, the Board may evaluate what, if any, further conditions are warranted for Dr. Bussell to practice medicine and impose such conditions on his license. If Dr. Bussell fails to meet the conditions of his conditional license, the Board also will consider whether to suspend, revoke, or otherwise discipline his conditional license.
7. Should Dr. Bussell wish to have any condition removed from his conditional license, he shall make a request in writing to the Board, at which time the Board would consider such request. When doing so, he shall provide evidence of full compliance with his monitoring contract with Pu`ulu Lapa`au and all other conditions.

Marvin B. Padnick, M.D.

After due consideration of the information received, it was moved by Dr. Desai, seconded by Dr. Kosasa and unanimously carried to defer Dr. Padnick's application pending additional information.

Reynold L. Rimoldi, M.D.
