#### <u>Chairperson's</u> Report:

#### A. <u>National and Industry Update</u>

Chairperson Lau reported there were no new national and industry updates.

### Executive Officer's Report:

#### A. Renewal of Licenses and Permits to Practice

Executive Officer Kai reported that for the third biennial renewal, CPAs were able to renew licenses and permits to practice via the online process and that a majority of CPAs who do so express their appreciation and approval of the online renewal option; however, many of these CPAs believe that renewing online will significantly expedite the renewal process. She noted that the Board's office and the Professional and Vocational Licensing Division staff remind these licensees that the online renewal process is an effective and time-saving data gathering procedure, but that the actual processing of the renewals continues to be

> done manually. Thus, the time it takes to process electronic renewals is not as short as many believe it could or should be.

#### C. Ethics

Committee Chairperson Hirai had no report; however, as requested by the Executive Officer, Mr. Hirai will follow up with Susan Coffey of the American Institute of Certified Public Accountants ("AICPA") for an update on the AICPA's progress in drafting model language to implement the recodification of the AICPA Code of Conduct.

#### D. <u>Legislation and Rules</u>

Committee Chairperson Williams had no report. Former Committee Chairperson Hirai commented that various committees of the State Legislature have already begun

> scheduling hearings on new bills for this Legislative session as well as carryover bills from the 2013 Legislative session.

As instructed at the Board's last meeting by DAG Tam, Mr. Hirai had asked Jessica Faige, legislative analyst for the House Judiciary Committee, to contact DAG Tam to discuss her concern relating to House Bill No. 716. DAG Tam commented that he did exchange email correspondence with Ms. Faige, and informed her that HRS chapters 92 and 436B already impose a license suspension period of not more than five (5) years. Because this limitation on the maximum length of a suspension is already specified in other statutes, House Bill No. 716, which proposes to amend HRS section 466-9(A)(2) relating to the Board's authority for disciplinary action, does not need to specify a similar limitation. It is, however, up to the Legislature to determine whether to insert this limitation in HRS chapter 466 or not.

#### F. <u>Peer Review</u>

Committee Chairperson Oberg stated that his report is combined with his report as Chairperson of the Investigative Committee on Peer Review.

#### G. Uniform CPA Examination

Committee Chairperson Regan had no report.

#### <u>Investigative</u> <u>Committee Reports</u>:

#### A. <u>Investigative Committee on Peer Review</u>

Investigative Committee on Peer Review ("ICPR") Chairperson Oberg reported that the submittal of the peer review administration plan by the Hawaii Society of Certified Public Accountants ("HSCPA") is pending. He mentioned that HSCPA is waiting for AICPA's approval, prior to its submittal to this Board. Chairperson Lau suggested that the Board should inquire about the possibility of reviewing the administration plan concurrently with the AICPA's review, as it was unclear what the process and how long the duration of AICPA's review would be. Executive Officer Kai was instructed to follow up with HSCPA Executive Director Kathy Castillo concerning the Board's request.

Mr. Oberg commented that the ICPR is still working on drafting administrative rules to implement the peer review law. He mentioned that the ICPR is considering a meeting with the HSCPA and the Peer Review Oversight Committee to determine whether and to what extent administrative rules are necessary to implement the peer review program.
