New Business: 2014 Legislative Session – House Concurrent Resolution 31 –

Requesting the Auditor to Conduct a Sunrise Review of the Licensure and

Regulation of Herbal Therapists

The Executive Officer reported that this Resolution requests the Auditor to conduct a study on the feasibility of licensing and regulating herbal therapists. There is nothing for the Board to do. The Executive Officer will monitor this Resolution and keep the Board apprised of its progression.

<u>Discussion Regarding What Does it Mean for an Acupuncturist to Diagnose Under Scope of Practice?</u>

The Chair stated that he was asked this question while he was attending a seminar at HICOM. Ms. Tsuchiyama stated that the Board discussed this matter at its June 2013 meeting. She recommended that persons be referred to the minutes of that meeting. Dr. Hashimoto agreed. Board members agreed by consensus that this inquiry has been answered and interested parties should refer to the June 2013 meeting minutes.

<u>Discussion Regarding Physicians Practicing Acupuncture Without Being</u> <u>Licensed as an Acupuncturist?</u>

The Executive Officer informed the Members that this matter has been discussed numerous times in the past. She stated that §436E-3.5, HRS, is clear. She added that in 2003, the Attorney General issued its opinion stating that physicians cannot practice acupuncture without being licensed as an acupuncturist.

The Chair asked what should people do if they know a physician is practicing acupuncture without a license. The Executive Officer replied that if anyone believes a physician is practicing acupuncture without being licensed as an acupuncturist, they need to file a complaint with the Regulated Industries Complaints Office ("RICO").
