Call to Order: There being a quorum present, Vice Chairperson Akasaki called the meeting to order at 8:48 a.m.

Agenda: The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by Hawaii Revised Statutes (“HRS”) section 92-7(b).

The agenda was taken out of order and continued with “Chapter 91, HRS, Adjudicatory Matters”.

Chapter 91, HRS,
Adjudicatory
Matters:

Vice Chairperson Akasaki called for a recess from the Board’s meeting at 8:49 a.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS chapter 91.

1. Settlement Agreements

- a. In the Matter of the Contractors Licenses of Pacific Energy Strategies, LLC; Steven P. Olsen; CLB 2010-79-L and CLB 2010-367-L

RICO received two complaints from licensed C-37 Plumbing specialty contractors that Pacific Energy Strategies, LLC and Steven P. Olsen (“Respondents”) were using their name and license information on building permits without their permission.

Respondents alleged that they had verbal agreements with the C-37 contractors to list them on the building permits.

RICO also alleges that that Respondents failed to provide all disclosures on several homeowner contractors.

The Board discussed the settlement agreement in which Respondents do not admit to violating any law or rule, but agree to pay an administrative fine of \$3,000.00 with payments of not less than \$250.00 to be paid by the last day of each calendar month beginning with the first full month after the Board’s approval of the settlement agreement.

After discussion, it was moved by Mr. Yamada, seconded by Mr. Lee, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board’s Final Order in the above case.

- b. In the Matter of the Contractors Licenses of KJ Walk, Inc. and Warren J. Israelson; CLB 2012-111-L and CLB 2012-141-L

RICO alleges that KJ Walk, Inc. and Warren J. Israelson (“Respondents”) utilized unlicensed persons, Juan Carlos Benevides and Reginald Adric, for the drywall installation and

carpentry work on the exterior and interior of Building C of the Hualalai Village construction project. The work consisted of hanging drywall lids and walls on the second floor, and taping and mudding on the ground floor.

The Board discussed the settlement agreement in which Respondents do not admit to violating any law or rule, but agree to pay an administrative fine, jointly and severally, of \$1,000.00.

After discussion, it was moved by Mr. Lee, seconded by Mr. Yamada, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order in the above case.

After discussion, it was moved by Mr. Lee, seconded by Mr. Yamada, and unanimously carried to defer consideration of conditional licenses for Darren Mertz, Valley Well Drilling LLC/Martin L. Guilmette, RME, and

Sione F. Moniati, RME/Big Island Windows Inc. pending additional information.

It was moved by Mr. Suehiro, seconded by Mr. Lee, and unanimously carried to approve all owner-builder exemption applications for the above, except for Mr. Selhorst and Ms. Eusebio's application. The Board will be advising Mr. Selhorst to withdraw or cancel his permit with the County since work on the construction of the building has not been started, and therefore Board approval is not required to sell his property.

1. Examination Committee:

The Contractors Examination Summary report for January 2014 was distributed in the Board's agenda packet.

3. Legislation Committee:
Peter H. M. Lee, Chairperson

Mr. Lee reported on the following bills:

H.B. No. 570 – This bill enhances penalties when an elderly person is targeted (maximum fine increased from \$10,000 to \$20,000). This bill was passed by the House Committee on Human Services and referred to the House Committee on Judiciary ("JUD") in 2013. This bill was carried over to the 2014 Legislative Session. The JUD held a hearing on this bill. The Board and RICO continued to testify in support of this bill, and the JUD passed this bill unamended.

HB No. 1500/S.B. No. 2613 – This bill defines "incidental and supplemental" work by using a sliding scale for the percentage of the total contract price or the total time involved to perform the work. The House Committee on Labor & Public Employment ("LAB") held a hearing on this bill and the Board testified in strong opposition because it has already made a determination on "incidental and supplemental" work pursuant to the recent Hawaii Supreme Court decision. This bill passed with an amendment (H.B. No. 1500, H.D. 1) to allow general contractors who do not possess a specialty license to perform work that is subordinate to but necessary to the completion of the project and for which the general contractors do not have a license, if the value of the work performed is equal to or less than one percent of the total contract price.

The Board noted that in the Iron Workers Stabilization Fund's ("IWSF") testimony for the January 28, 2014 hearing on this bill, the IWSF stated that the Board's October 22, 2013 Board's Final Order ("BFO") was drafted by DAG Tam; the BFO went totally against the Hawaii Supreme Court's holding and instructions; DAG Tam went out of his way to defy the

Court; it defies logic for DAG Tam to reach the conclusion that “incidental and supplemental” work could comprise up to 49% of the total project; DAG Tam believes that he is higher than our Court; and the BFO was carelessly crafted and clearly did not comport with the Court’s decision.

The Board disagreed with the IWSF’s testimony and did not appreciate the implication that the Board did not understand the DC 50 case. The Board members all agreed that the Board’s Final Order in the DC 50 case was the Board’s decision, not DAG Tam’s. DAG Tam only drafted what the Board decided and what the Board wanted in its BFO. Mr. Lee stated that the DAG does not make decisions for the Board, rather the Board works with its advising DAG who offers legal advice. The DAG assists the Board and drafts decisions as directed by the Board. Mr. Akasaki concurred with Mr. Lee in that the Board asks the DAG for legal advice and takes this advice into consideration, but ultimately the Board makes its own decisions. Mr. Matsuzaki stated that the Board asks the DAG for legal advice and discusses matters that are before the Board. The Board always comes to a consensus as a Board, on decisions on these matters. Mr. Kagawa added that the Board utilizes the DAG’s administrative knowledge to develop a clear understanding of the issues before the Board. Mr. Mochida stated that the Board also asks for DAG’s advice on legislation that amends the Board’s laws and how it affects other trades. Mr. Polischeck concurred with the other member’s comments and added that the Board also asks the DAG to research issues and uses this information to come to a decision. The consensus of the Board is that while it uses the legal services of its advising DAG, the Board itself makes the decisions, not the DAG.

The Board members unanimously agreed that the BFO in the DC 50 case was the Board’s decision, not DAG Tam’s. They read and understood the Court’s opinion, made their own decision, and directed DAG Tam to draft the BFO.

Although H.B. 1500, H.D.1, deleted the sliding scale of dollar amounts and percentages, it proposes to now limit “incidental and supplemental” work to 1% of the total contract price. The Board strongly opposes this because the 1% limit is a procurement requirement to list subcontractors to prevent bid shopping after the contract has been awarded. The procurement law requirement is not related to the definition of “incidental and supplemental” or the scope of work that contractors can perform. In addition, the 1% limitation is too low because there are multiple criteria to consider in the determination of 1% of the contract price. Furthermore, this bill is unclear as it can also be interpreted to allow general contractors to do any specialty contracting work for which they do not have a license as long as it is less than 1%. The Board concluded by stating that it stands by its October 18, 2013 Final Order in which it defined “incidental and supplemental”.

Mr. Lee stated that the Senate Committee on Commerce & Consumer (“CPN”) Protection heard S.B. No. 2613 yesterday (February 20). The Board testified in opposition to this bill. CPN deferred this measure.

H.B. No. 1639/S.B. No. 2093 – These bills amend HRS section 708-8302, which pertains to unlicensed contractor fraud, by clarifying that “intent to deprive” may be formed before or after the person obtains or exerts control over the property of another. H.B. No. 1639 was submitted by the Honolulu Prosecutor’s Office.

The House Committee on Consumer Protection and Commerce (“CPC”) held a hearing on H.B. No. 1639. The Board testified in support because this bill provides consumer protection by enhancing the prosecution of unlicensed contractor fraud. The CPC passed this bill unamended and it is still alive.

H.B. No. 2164 – This bill proposes to amend the definition of a specialty contractor. The House Committee on Labor & Public Employment (“LAB”) held a hearing on this bill and the Board submitted testimony that the proposed amendment may adversely affect general contractors and the public by prohibiting them from performing specialty contracting work because their primary operations are not that of a specialty contractor. The LAB deferred this measure.

S.B. No. 2912 is similar to H.B. No. 2164, but it is not identified as a companion bill. This bill has not been scheduled for a hearing.

H.B. No. 2583/S.B. No. 2475 - These bills propose to clarify that a licensed contractor who aids and abets an unlicensed contractor may be subject to additional discipline by the Board. The Board testified in support. The CPC and the Senate Committees on Commerce and Consumer Protection (“CPN”) and Judiciary and Labor (“JDL”) held hearings on these bills and both the house bill and the senate bill were passed unamended.

H.B. No. 2274 and S.B. No. 2824 are RICO’s administration bills with the same amendments but these bills have not been scheduled for any hearings.

S.B. No. 2076 – This bill also amends HRS section 708-8302, which pertains to unlicensed contractor fraud by clarifying that “intent to deprive” may be formed before or after the person obtains or exerts control over the property of another.

The Senate Committee on Judiciary and Labor (“JDL”) held a hearing on this bill. The Board testified in support because this bill provides consumer protection by enhancing the prosecution of unlicensed contractor fraud. The JDL passed this bill unamended.

S.B. No. 2618 – This bill proposed to increase the membership of the Board from 13 to 15. The composition of the Board is changed by increasing the number of contractors from 10 to 12. Of the 12, the number of specialty contractor members increases from 5 to 7. The remaining members are 2 public members (not licensed contractors) and one member is affiliated with a state apprenticeship program. The Board is opposed to this bill.

This bill was heard by CPN yesterday and was deferred.

H.B. No. 1527 is the same bill as S.B. No. 2618, but these bills are not identified as companion bills. This bill has not been scheduled for a hearing.

S.B. No. 2945 – This is the same bill as last year's S.B. No. 1293 which requires the C-13 Electrical, C-15 Electronic systems, C-62 Pole and line, and C-63 High voltage electrical classifications to have a journey worker or journey worker specialty electrician's license in order to qualify for a contractor's license. The Board reaffirmed its position in opposition of this bill, as it will close the door for otherwise qualified individuals to be licensed. This bill was heard yesterday (February 20, 2014) before the CPN and was deferred.

Mr. Suehiro stated that he is in support of this bill.

Mr. Lee briefly summarized the following carryover bills from the 2013 session:

H.B. No. 339/S.B. No. 1257 – These bills add a new section in HRS chapter 444 giving the Board discretion to accept reasonably equivalent knowledge, training, or experience if the Board investigates and makes a detailed written finding available for public inspection. The Board testified in opposition as discretion already exists in the rules, and the disclosure requirement may not be in compliance with HRS chapter 92F (Uniform Information Practices Act). The Board last year testified in opposition to these bills.

The Board confirmed its previous position in opposition to this bill.

H.B. No. 372 – This bill changes the composition of the Board by increasing non-contractor members from 3 to 8, and reduces the number of contractors from 10 to 5. Of the 8 non-contractor members, one must be from a building trades labor organization, representative of an apprenticeship program, and a representative from HIOSH. The Board was opposed to these bills.

The Board confirmed its previous position in opposition to this bill.

H.B. No. 671/S.B. No. 986 – These bills define “incidental and supplemental” work as no more than half percent of the total contract. S.B. No. 986 does not allow general contractors to perform such work. The Board opposed this bill. The House Committee on Consumer Protection & Commerce deferred this measure.

H.B. No. 695 – This bill exempts out-of-state electricians retained by a public utility to perform high voltage work from the Board of Electricians and Plumbers (“E&P”) license requirements and the one-to-one ratio of the Board’s laws. The E&P testified in opposition and the Board commented that the language regarding the one-to-one ratio is not clear. The House Committee on Consumer Protection & Commerce deferred this measure.

The Board confirmed its previous position on this bill.

H.B. No. 1154/S.B. No. 1301, S.D. 1 – These bills add the classifications of plumber air conditioning and refrigeration pipefitter and plumber fire sprinkler pipefitter, and includes them in the one-to-one ratio requirement. S.B. No. 1301, S.D. 1 requires the licensure of journey worker air conditioning and refrigeration plumbers and journey worker fire sprinkler plumbers. The Electricians and Plumbers Board supported S.B. No. 1301, S.D. 1, and the Contractors License Board’s testimony was limited to supporting the language regarding the one-to-one ratio. This bill was deferred by the House.

The Board confirmed its previous position on this bill.

S.B. No. 348 – This bill defines a general building contractor project as one involving four unrelated trades or crafts, and allows specialty contractors to do work involving two or more trades or crafts regardless of whether it is incidental work. The Board was opposed to this bill.

The Board confirmed its previous position in opposition to this bill.

S.B. No. 501 – This bill defines RME as one who directs and supervises employees pursuant to HRS chapter 443E (Electricians and Plumbers). The Board testified in opposition and the measure was held.

The Board confirmed its previous position in opposition to this bill.

State Wide Plumbing

State Wide Plumbing is requesting determination on the license required to install a tankless hot water installation rated above 200,000 BTU/H for a commercial application. The City and County Plumbing Division does not consider this as a boiler; however, the State Boiler Division considers units over 200,000 BTU/H as a boiler.

Recommendation: The C-4 Boiler, hot-water heating, hot water supply, and steam fitting license classification is required to install tankless hot water installations rated above 200,000 BTU/H for commercial applications.

Hawaiya Technologies, Inc.

Hawaiya Technologies, Inc. requests clarification on the C-15 Electronic systems contractor eligibility to bid as a prime contractor for security camera systems.

Jennifer Hamson of Hawaiya Technologies, Inc. appeared before the Board to request clarification on who can bid (the C-15 or C-13 Electrical) on this project. She understood that the C-13 can install conduits and the C-15 cannot, and therefore could not understand why a C-15 can bid this job if there is conduit work involved.

Steven Van Ness, owner of APN Alarm, was also present and submitted a letter that they believed both the C-15 and C-13 could bid on this project with the C-15 doing the appropriate camera installation work and other incidental work tied to the surveillance portion of the job, and subbing out the electrical portion (conduit install, electrical connections, and any other incidental work tied to the electrical portion of the job, etc.). The reverse would be true of the C-13 bidding the job and doing the electrical work and subbing out the C-15 portion.

The Board explained that if it is primarily a C-15 project, the C-15 can act as the prime and sub out the electrical work (e.g., the conduit work in this project) to a C-13 licensee; however, if it is not a C-15 project, then the C-15 cannot act as the prime and sub to a C-13.

Recommendation: The C-15 Electronic systems contractor can bid and perform the Security Camera System Project at Mayor Wright Homes, provided that the installation of the conduit work is subcontracted to a C-13 Electrical contractor.
