After some discussion, it was moved by Dr. Lui, seconded by Vice Chair Saito, and unanimously carried to approve both the board and executive session minutes of the March 31, 2014 meeting as circulated.

- 5. Old Business:
- a. <u>Association of Regulatory Boards of Optometry ("ARBO") Annual Meeting, June</u> 22-24, 2014, Philadelphia, Pennsylvania Request for Member Board Report

EO Matsushima noted that at their last meeting, the Board deferred their response to several questions for discussion during the ARBO Annual Meeting. ARBO is asking for the Board's policy or rule regarding telemedicine regulation and their policy or rule regarding board certification.

Dr. Lui reminded the Board that at their May 14, 2012 meeting, the Board adopted a policy on advertising post-licensure certifications. He recommended that item 7 of that policy be amended to read: "The Board does not deem passage of written examinations given by the NBEO prior to Hawaii state licensure to be a post-licensure certification. Rather, it is viewed as a [typical] means of meeting state licensing [licensure] requirements. [Indeed, 1998 NBEO Board policy states that "Passing any current National Board examination, including the TMOD examination, or any combination of current National Board examinations, is not equivalent to 'board certification'.]" (underlined material added, while bracketed material is to be deleted)

After some discussion, it was the consensus of the Board to respond to ARBO's questions as follows:

1. What is your Board's policy or rule regarding telemedicine regulation?

Board's Response: The Board's statutes and rules do not address telemedicine regulation, nor do they have a policy regarding telemedicine regulation.

2. What is your Board's policy or rule regarding Board certification?

Board's Response:

The Board's Policy on Advertising Post-Licensure Certifications pursuant to §16-92-52(3) and (6), HAR and §459-9(3) and (6), HRS is as follows:

- Justification for policy: This Board is concerned about optometrists
  representing themselves as being "Board Certified". The public could be
  mislead into thinking it represents a higher level of expertise than other
  licensed optometrists, or that it may even be a requirement to practice.
- 2. This Board recognizes there are various organizations offering post-licensure programs conferring among other things, "board certification", "maintenance of competence certification" and "fellowship status". This Board recommends all of these entities be referred to as Post-Licensure Certifications under this policy.
- 3. This Board recognizes Board Certification is traditionally specialty-based and represents significant additional training and expertise. Some optometric "Board Certifications", however, do not fit this definition of certification in training in a specialty. Inasmuch as these certifications have no bearing on Hawaii State licensure, this Board will not at this time determine the validity of any of these certifications. Furthermore, this Board makes no endorsement of post-licensure certifications.
- If an optometrist wishes to advertise a post-licensure certification, he or she must identify the entity issuing the certification. Identification by acronym (ABO, COVD, FAAO, etc.) is acceptable.
- 5. The optometrist must be able to provide verification he or she has achieved any post-licensure certification. Should this Board or any member of the public request information on or clarification of the certification, the optometrist must be able to provide a complete description of the certification and the process to attain it.
- The optometrist can make no claim a post-licensure certification makes he or she "better, superior, or more advanced" than other licensed optometrists in Hawaii.

> 7. The Board does not deem passage of written examinations given by the NBEO prior to Hawaii state licensure to be a post-licensure certification. Rather, it is viewed as a means of meeting state licensing requirements.

## b. ARBO OE Tracker – Email regarding upcoming OE Tracker changes

EO Matsushima stated that beginning July 1, 2014, optometrists who pay their OE Tracker annual subscription fee will receive unlimited CE certificate uploads for CE hours that are not listed in their account. CE providers will still be able to send CE attendance from their events into ARBO for direct uploading into OE Tracker. She said she sent an email with follow up questions to Sierra Rice. A copy of Ms. Rice's responses to those questions was distributed to the Board.

Chair Reynolds noted that if the optometrists do not pay the subscription fee, they will not be allowed to submit CE certificates themselves and would have to rely solely on the CE provider.

Dr. Lui asked whether the Board was considering making the use of OE Tracker optional.

EO Matsushima said yes. Ideally, ARBO would conform their report to meet the requirements in the Board's rules.

DAG Jacob stated that ultimately, it is the burden of the optometrist to provide the information requested. Previously, a few concerns about the report were raised that ARBO might not be able to work around. It is up to the Board to decide how to proceed. He noted that during the presentation, Ms. Rice had stated that there are about a dozen states currently using OE Tracker in some form.

EO Matsushima noted that she and Chair Reynolds have requested a meeting with Ms. Rice during the upcoming ARBO meeting to discuss OE Tracker.

DAG Jacob suggested that they also speak to representatives of the states that are currently using OE Tracker to see how the implementation is working for them.

EO Matsushima noted that at their July 25, 2011 meeting, the Board approved the Nova Southeastern University College of Optometry's Therapeutic Pharmaceutical Agents Certification Course, held July 7-16, 2011, as acceptable to fulfill the education requirement of a 100-hour board approved course in the

treatment and management of ocular diseases needed in order to obtain Hawaii TPA Certification.

After some discussion, upon a motion by Dr. Loo, seconded by Dr. Lui, it was voted on to approve Nova Southeastern University College of Optometry's Therapeutic Pharmaceutical Agents Certification Course, held July 10-19, 2014, as acceptable to fulfill the education requirement of a 100-hour board approved course in the treatment and management of ocular diseases needed in order to obtain Hawaii TPA Certification.

### b. Request from Joel Punzal, O.D. for Trade Name Approval
