Chair's Report:

The Chair thanked the members and staff for their patience and understanding in having to reschedule the meeting because he could not make the last meeting due to Hurricane Iselle.

Executive Officer's Report:

The Executive Officer introduced May Ferrer, another new executive officer with PVL. Ms. Ferrer is observing the meeting. Ms. Rutkowski explained that staff changes were made, which included the reassignments of boards. Ms. Kramer has been assigned to the Board of Acupuncture. Ms. Rutkowski has been reassigned to other boards.

Ms. Rutkowski thanked the members for their contributions and stated that during the years that she has been assigned to the Board, the profession has grown by leaps and bounds. She stated that over the years the Board has initiated several legislative actions that resulted in 1) recognizing the ACAOM accredited first professional or entry level program as the education and training requirement for licensure; 2) ensuring that those who studied at foreign schools attained the level of education at least equal to the ACAOM program; and 3) requiring that licensees who want to refer to themselves as Doctor of Acupuncture complete the ACAOM accredited doctoral program.

Pending/current issues that have arisen are dry needling by physical therapists, first professional doctoral degree, and rule revisions.

Old Business:

May 16, 2014 Request from Total Body Care, Inc., Shinji Tsukamoto, Regarding Use of Ultrasound and TENS Unit Combination Device and Traction Device for Lumbar Spine in the Practice of Acupuncture

The Executive Officer reported that Mr. Tsukamoto had not yet provided the additional information the Board requested. It was agreed by consensus to table this matter until Mr. Tsukamoto submits the additional information requested.

The Board has approved AACRAO to perform these education credential reviews.

After a brief discussion, it was moved by Dr. Hashimoto, seconded by Ms. Tsuchiyama, and unanimously carried to authorize WES, in addition to ACCRAO, to provide education credential review for applicants who attended schools outside of the United States.
