### c. <u>Legislation</u>

None.

# d. <u>Appraisal Management Companies ("AMC") Update</u>

Executive Officer Taniguchi stated that the Appraisal Subcommittee's ("ASC") final rules on AMC regulations and its' mandatory audit process/oversight controls were published, and its effective date is August 10, 2015. He further stated the Department of Commerce and Consumer Affairs ("Department") has three (3) years to decide whether or not to regulate AMCs.

### e. Right of Way Agents

Chairperson Stellmacher stated that the Department of Human Resources Development inquired whether an appraiser's license would be required for Right of Way Agents (employees related to the Department of Transportation, Highways Division), as it appears that they may be performing real estate appraisal work. Mr. Chen commented that levels one and two of Right of Way Agents are entry level staff members with a supervisor who holds an appraiser's license; thus, not subject to hold an appraiser license. Mr. Chen further commented that levels three (3) and up of Right of Way Agents hold an appraiser's license.

Executive Officer Taniguchi stated that entry level Right of Way Agents must register with the Department as appraiser trainees. The trainee's supervisor would also need to be qualified by completing the Supervisor/Trainee course.

Unfinished Business:

None.

The Appraisal Subcommittee:

Jenny Tidwell and Neal Fenochietti, Policy Managers from ASC were introduced and welcomed by the Committee. Mr. Fenochietti

gave a brief history/description of ASC which oversees the appraisal regulatory programs established by States.

Mr. Fenochietti provided the following preliminary findings from this Program's bi-annual field review for compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989:

- Statute/Rules: the language in the rules should be amended to include the minimum AQB Criteria for Trainee appraisers; it was noted that in practice, the State is complying with AQB Criteria for trainee appraisers. Also the current language of the supervising appraiser's good standing and not subject to any disciplinary action within the last two (2) years needs to be changed to three (3) years to meet the AQB Criteria.
- Temporary Practice: "all in order/no issues".
- National Registry: "no issues".
- Application Process: "no issues".
- Reciprocity: "no issues".
- Education: course provider agreements "no issues".
- Enforcement: "no issues" but noted an encouragement that background checks of supervisors needs to be checked?

Mr. Fenochietti stated that a preliminary findings "ASC staff report" will be sent to the State, and the State will be given 60 days to respond with a plan to correct/address concerns found from their field review. ASC staff will consider the State's response and make a formal recommendation(s) to ASC for final disposition. ASC will consider the State's response and ultimately issue a final Compliance Review Report and letter to the State with a determination regarding the State's compliance with Title 11.

Ms. Tidwell stated that effective January 1, 2015, all appraiser trainees and their supervising appraisers must meet the minimum course requirements. The supervisor's course is a one-time course
