- 2. Determine, pursuant to §16-201-86(b), Hawaii Administrative Rules, that the inquiry is not appropriate for the issuance of an informal interpretation, due in part that:
 - a. the facts set forth by the requestor are not sufficiently detailed and clear to allow the Board or Commission to understand the requestor's circumstances; and
 - there has been no consistent historical pattern of deciding similar inquiries upon which the Board or Commission can base its response.
