- Principal Broker (PB)/Broker in Charge (BIC) linking the Entities license if authorized by the entity to do so.
- Individual licensees should not link to other individual licensees. The following are examples of licenses that should not be link:
 1. Salespersons/Broker Salespersons should not be linked to other salespersons/broker salespersons.
 2. Salespersons/Broker Salespersons should not be linked to associating brokerage.
 3. PBs should not be linked to associating salespersons/broker salespersons.
