Upon a motion by Commissioner Faulkner, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the minutes of the May 14, 2014 Education Review Committee meeting.

Senior Specialist Fujimura stated that five minutes have been added to the "HUD Memorandum" and "Social Media and Internet Policy" sections of the course to bring the total number of minutes to the required minimum of 180 minutes. The "Social Media and Internet Policy" section is included in the course because there is much discussion on this subject when teaching Core A.

Commissioner Faulkner pointed out a few typographical errors on page 25 of the handouts.

Upon a motion by Commissioner Gendrano, seconded by Commissioner Faulkner, it was voted on and unanimously carried to approve "Fair Housing and Advertising," as a three-hour elective course, under the course categories: Real Estate Law, Property Management, Risk Management, Technology and the Licensee, and Broker Management.

Continuing Education Core Course

Copies of the second draft of the Core B 2013-2014 course were distributed to the Commissioners for their information.

Senior Specialist Fujimura stated the section discussing "designated agency" was removed because the practice is not recognized in Hawaii. Commissioner Gendrano expressed surprise that "designated agency" has not taken off here since it is used in many states on the Mainland.

Commissioner Faulkner pointed out a few typographical errors on page10 under the heading, "Firewall for Dual Agency Transactions."

Senior Specialist Fujimura announced that registration forms for the Train-the-Trainer session have been sent out via email. The Train-the-Trainer session is required for an instructor to teach Core Course B. The session is being offered live at the Honolulu Board of REALTORS® and also via webinar on July 14, 2014. She reported that so far there are 10 people registered for the live class and 2 people for the webinar.
