it was voted on and unanimously carried to accept the minutes of the

September 10, 2014, Laws and Rules Review Committee meeting as circulated.

EO Ino announced that Staff has just been informed that effective October 20, 2014 with the start of the December 2014 renewals, PVL and RICO will be increasing their initial and renewal licensing fees pursuant to HRS §92-28. Fees

have not increased since 1982 when DCCA became self-sufficient. The reasons for the increases are to replace the ALIAS and CMS systems, to upgrade the telephone systems; and to retain an adequate reserve balance for each division which is critical to ensuring acceptable public service.

The increase has ranged from 17% to 22%. The Director's Office will be issuing a notice on the increase of fees.

REB staff is in the process of revising its forms and notices by October 20, 2014, the real estate renewal go live date.
