Mr. Carlton Choy was present to answer questions. Senior Real Estate Specialist Fujimura stated that Mr. Choy has submitted information documenting his real estate-related teaching experience teaching for review by the Commission.

Mr. Choy stated that he loves teaching. He noted that younger students need to be taught differently than older students, and it is important to emphasize the code of ethics for real estate license candidates. Commissioner Pang expressed his appreciation of Mr. Choy's thorough and complete application.

Upon a motion by Commissioner Arakaki, seconded by Commissioner Sherley, it was voted on and unanimously carried to approve Mr. Carlton D. Choy as a Prelicense Instructor, Salesperson Curriculum, for Inet Realty.

# Instructor – Elarka S. H. Yuen, Salesperson and Broker Curricula; School: Coldwell Banker Pacific Properties Real Estate School, Principal – Trudy Nishihara

Ms. Elarka Yuen was present to answer questions. Ms. Yuen stated that she has been a guest lecturer for Coldwell Banker since August 2013. She enjoys instructing the prelicensing topics and especially, ethics. However, she stated it is a challenge to ensure information is current and up-to-date.

Commissioner Wada questioned whether more experience is needed to teach the broker curriculum. Senior Specialist Fujimura explained that the requirements to be a prelicense instructor include practicing as a broker in Hawaii, and meeting the broker experience qualifications. All prelicense instructors, therefore, have
