- Each branch office shall have at least one (1) broker in charge. Submit a *Change Form* to register a broker in charge for the brokerage firm if the principal broker has not already designated a broker in charge. No change form fee is required if submitted with Application for Registration: Real Estate Branch Office.**
- The principal broker shall certify that the information provided is true and correct by signing below.
- If registering in an odd-numbered year, pay\$285
(Nonrefundable application fee - \$25 + Registration fee - \$30 + Education Fund fee - \$40 + Recovery Fund fee - \$50 + 1/2 Renewal fee - \$30 + CRF - \$110)

If registering in an even-numbered year, pay.....\$199
(Nonrefundable application fee - \$25 + Registration fee - \$30 + Education Fund fee - \$40 + Recovery Fund fee - \$50 + CRF - \$54)

Attach check payable to "Commerce and Consumer Affairs". A \$25.00 service charge shall be assessed for payments that are dishonored for any reason.
