In the Matter of the Real Estate Salesperson's License of Bradley Y. Saguid: REC 2019-160-L

Marc Nakamura, Esq., of the Regulated Industries Complaints Office was present via videoconference. Bradley Saguid was present via teleconference. Mr. Nakamura and Mr. Saguid both presented oral testimony. Mr. Saguid acknowledged that he received the notice of violation of the terms of the settlement agreement via email from Marc Nakamura, and that he received the notice of license revocation via USPS mail from the Real Estate Branch.

Upon a motion by Commissioner Pang, seconded by Commissioner Ginoza, it was voted on and unanimously carried by roll call vote not to revoke the real estate salesperson's license of Bradley Y. Saguid for violating the terms of the settlement agreement in this matter provided Mr. Saguid comply with the terms of the settlement agreement and that the obligation is paid in full by January 28, 2022. Failure to satisfy the terms of the settlement agreement may result in revocation of real estate salesperson's license at the January 28, 2022 Real Estate Commission meeting.
