She added that Paul Roy, expert in the subject matter was also in attendance.

> Upon a motion by Commissioner Pang, seconded by Commissioner La Costa, it was voted on and unanimously carried by roll call vote to approve the course "Ninja Selling" as a 15-credit hour continuing education elective course under the course category consumer and client focused real estate business practices.

> Course - "Stay Safe! Personal Safety/Security and Covid-19 Best Practices"; Author/Owner – Bryan Andaya; Provider – Eddie Flores Real Estate Continuing Education; Course Categories - Risk Management, Broker Management, Other -Personal Security/Safety; Clock Hours - 3

Mr. Andaya was present via teleconference and thanked the Commission for considering this new course. He stated that this course included real-life examples, tips on how to improve personal safety, and covered Covid-19 safety. He added that best practices as required by OSHA were also covered. Commissioner Pang stated the course offered useful information. Commissioner Abe stated that the course was well done.

Commissioner Senter disclosed that she knew Mr. Andaya but could make a fair and impartial decision in this matter.

Upon a motion by Commissioner Pang, seconded by Commissioner Abe, it was voted on and unanimously carried by roll call vote to approve the course "Stay Safe! Personal Safety/Security and Covid-19 Best Practices" as a 3-credit hour continuing education elective course under the course category risk management, broker management, personal security/safety.

Licensing – Applications:

The Chair informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

# **Samuel James Campiformio**

Commissioner Pang moved to deny the request for reconsideration of the real estate broker restoration application and sole proprietor application of Samuel James Campiformio. He noted that the applicant also filed for a contested case hearing with the Office of Administrative Hearings and would be presenting his appeal in that forum. Commissioner La Costa seconded the motion. The motion was voted on and unanimously carried by roll call vote.

#### **Kristian Chavez**

After review of the information provided by the applicant, Commissioner Pang moved to approve the real estate salesperson license of Kristian Chavez. Commissioner Kyono seconded the motion. The motion was voted on and unanimously carried by roll call vote.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 9:22 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate Salesperson's License of Jennifer H. L. Randall: REC 2020-316-L

Commissioner Pang moved to accept the settlement agreement of Jennifer H. L. Randall. Commissioner Abe seconded the motion. Commissioners Pang, Abe, Andrews, Ginoza, Kyono, Senter and Yamane voted aye. Commissioner La Costa abstained from the vote. The motion carried.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:27 a.m.

Licensing – Applications:

It was brought to the Chair's attention that Mr. Campiformio had his virtual hand raised however, he was no longer present in the meeting. Deputy Attorney General Paige informed the Commission that they could contact Mr. Campiformio to inquire if he would still like to address the Commission. Real Estate Specialist Jackson contacted Mr. Campiformio and informed him that the Commission meeting was still in session.

Mr. Campiformio rejoined the meeting via teleconference and thanked the Commission for hearing him. He stated the request for reconsideration was an interesting process and asked if the reason his request could not move forward was based on a technicality. Chair Pang responded that the Commission did not have jurisdiction over the matter. Mr. Campiformio stated that he was only aware of the 60-day timeline to request a contested case hearing. He stated that he would like to make a recommendation that applicants are made aware of the request for reconsideration timeline.
