The Crime Prevention and Justice Assistance Division (CPJAD) serves as the central agency to provide the Attorney General, with information and resources needed to address crime and crime prevention. The division has five branches:

- The Research & Statistics Branch conducts research on crime issues and reports comprehensive crime statistics for the state.
- The Grants & Planning Branch utilizes federal and state funds and non-financial resources to address crime problems and criminal justice issues.
- The Juvenile Justice Information System developes and maintains a computerized juvenile offender information system.
- The Missing Child Center Hawaii assists in locating, recovering, and reuniting missing children and runaways.
- The Community and Crime Prevention Branch is responsible for the planning and implementation of informational and educational workshops and activities focused on community crime prevention. Topic areas by the branch include: Identity theft, frauds, and scams, Internet safety, Substance abuse prevention, McGruff crime prevention campaign in Hawaii, Sexual violence prevention and more!

Executive Office on Aging Senior Medicare Patrol (SMP) Hawaii

The Senior Medicare Patrol (SMP) Hawaii is funded by the United States Administration on Community Living to help beneficiaries, family members and caregivers Protect, Detect, and Report.

PROTECT: Protect your personal information and Medicare number, review Medicare statements, review your credit report, etc.

DETECT: Keep a journal and compare your recorded visits to your Medicare summary notice.

REPORT: Don't get pressured into giving your Medicare number to anyone. If you have been victimized, report it right away!

SMP Hawaii trains and coordinates volunteers in every county to educate their community on how to prevent healthcare ID theft, billing errors, scams, abuse and fraud.

SMP Hawaii participates in community fairs, conduct presentations and classes on Medicare fraud prevention, and even has their own drama club that performs skits state wide. They also provide one-to-one, individual counseling for those who request their services.

Narcotics Enforcement Division (NED)



The Narcotics Enforcement Division (NED) is a statewide law enforcement agency that serves and protects the public by enforcing State laws pertaining to controlled substances and regulated chemicals. They are responsible for the registration and control of the manufacture, distribution, prescription, and dispensing of controlled substances and precursor or essential chemicals within the State.

NED is also responsible for assuring that pharmaceutical controlled substances are used for legitimate medical purposes. They register and investigate all violation of persons who administer, prescribe, manufacture or dispense controlled substances in the State, including those who work at methadone clinics.
