

The Certificate of Status shows the official evidence of an entity's existence and provides a statement of an entity's status, current legal name, and date of formation. The Certificate of Status bears the official seal of the Hawaii Secretary of State.

GA Business Compliance will not disclose any information about your business to any third-party, including competitors, unless required by force of law.
