**INSTRUCTIONS FOR PREPARING AND FILING
ARTICLES OF AMENDMENT TO CHANGE A DOMESTIC NONPROFIT CORPORATE NAME**
Section 414D-183, Hawaii Revised Statutes (HRS)

Articles must be typewritten or printed in **black ink** and must be **legible**. The articles must be signed by a presiding officer of the board of directors, or by at least one officer of the corporation. All signatures must be in **black ink**. Submit articles together with the appropriate fee(s).

Item 1. State the full name of the corporation prior to the change.

Item 2. State the new, full name of the corporation.

Item 3. State the date the amendment(s) was/were adopted (MM/DD/YYYY) and indicate whether the amendment to change the corporate name was adopted at a meeting of the members, by written consent of the members holding at least eighty percent of the voting power, or by a sufficient vote of the board of directors or incorporators because member approval was not required.

- If the amendment(s) was/were adopted at a meeting of the members, complete the table with details of the vote (Designation (class) of Membership, Total Number of Membership Votes Outstanding, Total Number of Votes Entitled to be Cast by Each Class, Number of Votes Cast by Each Class For the Amendment and Number of Votes Cast by Each Class Against the Amendment).
- If the amendment(s) was/were adopted by written consent in lieu of a meeting, the written consent must be signed by members holding at least eighty percent of the voting power.
- If approval of members was not required, the amendment(s) must be approved by a sufficient vote of the board of directors or incorporators.

Item 4. Check whether written approval of the amendment by a third person or persons named in the articles of incorporation was obtained or whether approval of a third person is not required.

Filing Fees: The fee for filing the Articles of Amendment is **\$10.00** and is not refundable. Optional: the fee for one certified copy is \$10.00. Payments made by cash, check, or credit card are accepted. Make checks payable to DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS. Dishonored check fee is \$25.00.
