The duct line will proceed Northwest for approximately 26 lineal feet (LF), then turn Southwest for

		approximately 90 LF and terminate at an existing manhole located within Wheeler Army Airfield.

The proposed project will consist of constructing an open trench to install 2-4" PVC conduits, concrete encased with a duct drain and then back fill the open trench. Also included is connecting the conduits to existing manhole at each end of the duct line, reconstruct an existing concrete curb and gutter. Then repave and restripe Kamehameha Highway.


