Dear Mr. Kang:

This is to inform you that the ascertainment proceeding for Oceanic Time Warner Cable LLC ("OTWC"), dba Oceanic Time Warner Cable, for the renewal of its Maui County and Lahaina/West Maui Franchises is completed as of the date of this letter. Pursuant to Hawaii Administrative Rules ("HAR") §16-133-28, OTWC is required to submit a written application for renewal within twenty-eight (28) calendar days from this date (no later than August 30, 2013). As stated in the Department's August 16, 2012 letter to you, the Department will accept a single set of the written application and exhibits which incorporate both franchise renewals for Maui County and Lahaina. However, a separate filing fee of \$1,000.00 for each franchise renewal must accompany OTWC's written application for renewal.

With the completion of the ascertainment proceeding and upon submission of OTWC's renewal application, certain procedures set forth in HAR §16-133-26 through §16-133-32 are required. Specifically, HAR §16-133-31 requires that within four months of the date of this notice (by December 2, 2013), the Director shall approve or deny OTWC's application.
