Re: Letter Order – Payment for Contract for Goods or Services Based Upon Competitive Sealed Proposals, RFP-CATV-16-001-SW

On January 3, 2017, the Department of Commerce and Consumer Affairs ("DCCA") issued Decision and Order ("D&O") No. 369, directing Oceanic Time Warner Cable LLC ("OTWC") in Section III. B. 3. b., of the D&O to set aside and maintain FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000.00) in an interest bearing account in a federally insured financial institution.<sup>1</sup> OTWC was allowed to recover the reasonable costs of administering the bank account, including the tax impact of any interest earned from the interest on the account, and if requested by the Director of DCCA ("Director"), OTWC is required to disperse the funds to any entity designated by the Director.<sup>2</sup>

At this juncture, the Director requests that OTWC pay FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000.00) to Makauila, Inc. pursuant to the Contract for Goods or Services Based Upon Competitive Sealed Proposals, RFP-CATV-16-001-SW effective January 1, 2017.

Accordingly, pursuant to Section III. B. 3. b. of D&O No. 369; and the Contract for Goods or Services Based Upon Competitive Sealed Proposals, RFP-CATV-16-001-SW; DCCA hereby orders that:

1. OTWC shall pay FIFTY THOUSAND AND NO/100 (\$50,000.00) to Makauila, Inc. on or about May 15, 2017, with the payment sent to the following address:

- 2. OTWC shall provide copies of the payment check and any supporting documents to DCCA.
- 3. Any future payments to Makauila, Inc. shall be based on a subsequent Letter Order issued by DCCA.
- 4. Except as provided herein, the remaining provisions of D&O No. 369, shall remain in full force and effect.
