<u>Letter Order – Payment of \$7.92 Million Out of Time Warner Trust Fund</u> (also known as the Charter Communications Trust Fund) to the State of Hawaii Department of Education

Dear Mr. Fujimoto:

In accordance with Decision and Order ("D&O") No. 346, Section IV.I.4, issued on January 14, 2010, and pursuant to the Supplemental Appropriations Act of 2018, Act 53, 2018 Session Laws of Hawaii, the Department of Commerce and Consumer Affairs hereby directs Oceanic Time Warner Cable LLC ("OTWC") to pay from the Time Warner trust fund (also known as the Charter Communications trust fund) established pursuant to D&O No. 346, the sum of SEVEN MILLION NINE HUNDRED TWENTY THOUSAND and NO/100 dollars (\$7,920,000.00) to the State of Hawaii Department of Education ("DOE"). This funding will allow the DOE to upgrade the equipment to transport network traffic, add additional fiber between strategic institutional network sites and bypass points, and to increase bandwidth by upgrading or replacing fiber connectivity and associated telecommunications equipment in schools.
