O R D E R
AMENDING ORDER NO. 5

IT APPEARING That CABLEVISION INCORPORATED, hereinafter referred to as "Cablevision" was issued an Order dated October 21, 1970, granting a non-exclusive CATV permit to operate for a term of twenty (20) years beginning with the effective date of said Act in the service area on the Island of Oahu identified in Exhibit "A" attached thereto and described therein;

IT FURTHER APPEARING That said Order excluded an area where one home is served with cable television and wherein the head-end antenna is located; said head-end antenna was installed prior to June 1, 1969;

IT FURTHER APPEARING That Enumeration District 198 of Census Tract 86.01 includes the area wherein said home is being served and wherein the head-end antenna is located; said Enumeration District 198 of Census Tract 86.01 is described and identified as follows:

Pacific Ocean, Pili O Kahe Gulch, Palehua Road, H-1, Makakilo Gulch, Power Line, Farrington Highway, H-1, Farrington Highway, extended Hawaiian Electric Company's easterly boundary to the Pacific Ocean.

IT FURTHER APPEARING That the granting of service areas based upon legally recorded boundaries with the U.S. Department of Commerce, known as census tracts, is most practicable at this time;

IT FURTHER APPEARING That the Cable Television Division had investigated and initiated this matter and recommended the approval for the amendment of the service area as granted to Cablevision in Order No. 5 dated October 21, 1970.

WHEREFORE AND GOOD CAUSE APPEARING, THEREFORE, IT IS HEREBY ORDERED That Order No. 5 be amended to show the service area identified in Exhibit "B" attached hereto and made a part hereof and described as follows:

South boundary of Kaena Military Reservation extended, South boundary of Kaena Military Reservation, top of South rim of Waianae Range, South boundary of Military Reservation, crest of Waianae Range, West boundary of Schofield Barracks Military Reservation (crest of Waianae Range), North and West boundaries of Lualualei Naval Ammunition Depot, West boundary of Schofield Barracks Military Reservation (crest of Waianae Range), crest of Waianae Range (West boundary of Honouliuli Forest Reserve), Honouliuli Forest Reserve boundary, Palehua Road, H-1, Makakilo Gulch, Power Line, Farrington Highway, H-1, Farrington Highway, extended Hawaiian Electric Company's easterly boundary to the Pacific Ocean.



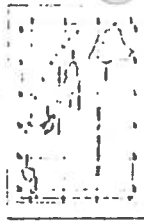
