O R D E R

The Director of Regulatory Agencies, upon consideration of the request, plans and justifications contained therein of CABLEVISION, INCORPORATED for an extension of the time allowed in condition number one (c) of Order No. 12 which requires that:

"1. The permittee shall complete construction of distribution and origination facilities and begin service to:

"c. All potential subscribers within an existing service area of the permittee (for which a permit was awarded prior to the 31st day of January, 1971), within one year of the award of this permit."

hereby extends to May 12, 1973 the time allowed CABLEVISION, INCORPORATED for the complete construction of distribution facilities and the beginning of service to all potential subscribers in U.S. Bureau of the Census Tract Nos. 96.01, 96.02 and 97. These tracts are described as follows:

22nd, Lualualei Naval Road, Lualualei Naval Road extended.

Bounded by: Unnamed stream, Farrington Highway, Maiuu Road, Maiuu Road extended, Crest of Kamaileunu Ridge.

West boundary of Schofield Barracks Military Reservation (Crest of Waianae Range), North and west boundary of Lualualei Naval Ammunition Depot.

North and west boundary of Lualualei Naval Radio Station, Mailiilii Channel.
