ORDER NO. 84

ORDER

Upon consideration of the request dated September 25, 1981 and the justifications presented in support herein of THE SEVEN TWENTY CORPORATION for a modification of the requirement contained in Condition One of Cable Order Number 83 which requires that:

"1. The Limited Partnership shall provide the Director within sixty days of the issuance of this Order, a certification by a regulated financial institution that one million dollars (\$1,000,000) is on deposit to the account of the Limited Partnership, and that an unconditional letter of credit from a regulated financial institution assures that an additional five hundred thousand dollars (\$500,000) is available for immediate call down for a period of at least 18 months."

The Director of Regulatory Agencies hereby modifies the above requirement to read:

"1. The Limited Partnership shall provide the Director within sixty days of the issuance of this Order, a certification by a regulated financial institution that nine hundred fifty thousand dollars (\$950,000) is on deposit to the account of the Limited Partnership and that an unconditional letter of credit from a regulated financial institution assures that an additional five hundred and fifty thousand dollars (\$550,000) is available for immediate call down for a period of at least 18 months."

The modification of Condition One of Order Number 83 is conditioned upon submission to the Director within fourteen days of the issuance of this Order, an audited report of the financial condition of THE SEVEN TWENTY CORPORATION.

b) Installation charges may be waived or substantially reduced.

- ^{1/} Tier I consists of the five Honolulu TV stations; two satellite independent TV stations; one satellite cable news channel; one shared channel for local access, Filipino programming, Trinity Broadcast Network and Praise the Lord Network; one shared channel for sports and other entertainment; and two pay movie channels at an additional charge for each. No converter is required and 12 channels of services are to be provided.
- ^{2/} Tier II contains all of Tier I and the addition of channels for leased access, government access, public access, educational access, hotel/condo service, and two channels reserved for future pay TV and satellite service. Tier II requires a converter for mid-band use of the television spectrum.
- ^{3/} Tier III will contain all of Tiers I and II with the addition of channels reserved for future use. At this time, there are no planned services for Tier III except what is planned for Tiers I and II. Converters would be required for the use of mid-band and super-band television channels.
- ^{4/} Tier I consists of the five Honolulu TV stations; two satellite independent TV stations; one shared channel for local origination and public access; two channels for educational and government access; one satellite channel for religious programs; and one satellite channel for cable news. No converter is required and 12 channels of services are to be provided.
- ^{5/} Tier II consists of HBO and two additional channels for USA/C-Span and Nickelodean satellite channels. USA/C-Span is a sports/news/government channel and Nickelodean is a children's program. The monthly charges for Tier I are required and in addition to the monthly charges for Tier II.
- ^{6/} Tier III includes Tier II programs with the addition of Showtime and Galavision. Showtime and Galavision may not be requested without Tier II. The monthly charges for Tier I are required and in addition to the monthly charges for Tier III.
- ^{7/} Either HBO or Warner movies may be subscribed to at an additional cost to all tiered services.
- ^{8/} Both HBO and Warner movies may be subscribed to at an additional cost to all tiered services.
- ^{9/} Part of Tier II.
- ^{10/} Part of Tier III.
