Re: Letter Order – Spectrum Oceanic, LLC Franchise Fees Paid by the
Cable Operator – Hawaii Island Cable System

Dear Mr. Fujimoto:

In Decision and Order (“**D&O**”) No. 379, issued on December 29, 2021, Spectrum Oceanic, LLC (“**Spectrum**”) was directed by the Director of the Department of Commerce and Consumer Affairs (“**Director**”) to hold one and a half percent (1.5%) of its annual gross revenues from its Hawaii island Cable System to be maintained by Spectrum in an interest bearing account in a federally insured financial institution authorized in the State of Hawaii to be distributed at a later date at the sole discretion and direction of the Director (see, Section III.B.4.).

Accordingly, pursuant to D&O No. 379, the Director hereby orders and directs that:

1. Within thirty (30) days of the date of this Letter Order, Spectrum shall distribute the remaining one and half percent (1.5%) of annual gross revenues from its Hawaii Island Cable System, and any accrued interest, to the Hawaii island public, educational and governmental (“**PEG**”) access organization as Access Operating Fees;

2. Spectrum may recover from the amount described in Paragraph 1, above, the reasonable costs associated with opening and administering the bank account, including the tax impact of any interest earned from the account; and
3. Within ten (10) days of the distribution to the Hawaii island PEG access organization, Spectrum shall provide written notice to DCCA along with supporting documentation detailing the interest accrued and any fees and expenses Spectrum incurred and recovered relating to said funds.
