Dear Mr. Fujimoto and Mr. Golden:

In Decision and Order ("**D&O**") No. 375, issued on May 9, 2019, Spectrum Oceanic, LLC and Hawaiian Telcom Services Company, Inc. (collectively, "**Cable Operators**") were directed by the Director of the Department of Commerce and Consumer Affairs ("**Director**") to hold all annual fees collected from cable television subscribers for the period January 1, 2019 through June 30, 2019 until further ordered by the Director (see, Section III.C.).

Accordingly, pursuant to D&O No. 375, Section III.C., the Director hereby orders and directs that the amounts collected from cable television subscribers from January 1, 2019 through June 30, 2019 and held by the Cable Operators, including any applicable interest earned, shall be paid as an Annual Fee to the Department of Commerce and Consumer Affairs within thirty (30) days of the date of this Letter Order.
