Re: Letter Order – Payment for Contract for Goods or Services Based Upon Competitive Sealed Proposals, RFP-CATV-22-002-SW

On December 29, 2021, the Department of Commerce and Consumer Affairs ("**DCCA**") issued Decision and Order ("**D&O**") No. 379, directing Spectrum Oceanic, LLC ("**Spectrum**") in Section III.B.5. of the D&O to set aside and maintain THREE HUNDRED THOUSAND AND NO/100 DOLLARS (\$300,000.00) in an interest bearing account in a federally insured financial institution.¹ Spectrum was allowed to recover the reasonable costs of administering the bank account, including the tax impact of any interest earned from the interest on the account, and if requested by the Director of DCCA ("**Director**"), Spectrum is required to disperse the funds to any entity designated by the Director.²

At this juncture, the Director directs that Spectrum pay THREE HUNDRED THOUSAND AND NO/100 DOLLARS (\$300,000.00) to Makauila, Inc. ("**Makauila**") pursuant to the Contract for Goods or Services Based Upon Competitive Sealed Proposals, RFP-CATV-22-002-SW, effective November 1, 2022.

Accordingly, pursuant to Section III.B.5. of D&O No. 379; and the Contract for Goods or Services Based Upon Competitive Sealed Proposals, RFP-CATV-22-002-SW; DCCA hereby orders that:

1. Spectrum shall pay THREE HUNDRED THOUSAND AND NO/100 (\$300,000.00) to Makauila on or about November 30, 2022, with the payment sent to the following address:

- 2. Spectrum shall provide copies of the payment check and any supporting documents to DCCA.
- 3. Any future payments to Makauila shall be based on a subsequent D&O or Letter Order issued by DCCA.
- 4. Except as provided herein, the remaining provisions of D&O No. 379, shall remain in full force and effect.
