Re: Docket No. 2020-0084, Notice of Status Conference on **Wednesday, June 10, 2020**.

By this letter, the Commission gives notice that it will convene a virtual status conference, to be held on **Wednesday, June 10, 2020, from 1:00 PM to 3:00 PM** via WebEx.

The first 30 minutes of the Status Conference will provide Young Brothers, LLC ("YB") with an opportunity to present to the Commission on topics including YB's current access to financing and its contingency plans, as discussed in its May 29, 2020 "Requested Information Regarding Young Brothers, LLC's Access to Financing, Financial Impact, and Contingency Plans" filed in Docket No. 2020-0084,¹ YB's May 26, 2020 letter "Notice Regarding YB, LLC's Liquidity Crisis and Potential Suspension of Operations,"² and as addressed in Order No. 37161, filed in Docket No. 2020-0084 on June 2, 2020.³

During the subsequent 90 minutes of the Status Conference, the Commission and the Consumer Advocate will have the opportunity to ask questions and provide comments regarding the information presented by Young Brothers, and other issues that have come up in YB's above-mentioned filings and other documents filed with the Commission addressing YB's financial condition.

The Commission will file a more detailed agenda for the Status Conference in this docket, and will post the agenda on its website (<https://puc.hawaii.gov/>) on Monday, June 8, 2020.

The Commission will be holding this Status Conference via WebEx, and it will be accessible to the public for viewing. The Commission will post the WebEx details for viewing the Status Conference both in this docket and on the Commission's website on June 8, 2020, along with the agenda. The Commission notes that the public will be able to view, but will not be able to participate in, this June 10 Status Conference. Any person or
