

**Argosy University
Articulation Agreement with Crown College**

Argosy Education Group, Inc. ("Argosy University"), with offices at 3601 West Sunflower Avenue, Santa Ana, CA 92704, and Crown College, with offices at 8700 College View Drive, St. Bonifacius, MN, have entered into this Articulation Agreement ("Agreement") for the transfer of credits to benefit those students who wish to pursue a degree at Crown College.

Articulation Agreement

Argosy University and Crown College agree to the following:

- Crown College will draft and maintain Course Transfer Guides as an addendum to this Agreement, which identifies the Argosy University courses which satisfy specific courses, or may serve as substitutes, in Crown College's Programs of Study (POS). This includes the School of Online Studies/Graduate School and the School of Arts & Sciences.
- Under this Agreement, students who complete the courses listed on the Course Transfer Guide, with a grade of "C-" or better for undergraduate courses and "B-" or better for graduate courses, will receive transfer credit for those courses that are required in the chosen program of study at Crown College.
- Crown College will work with its regional accreditation agency, state authorities and programmatic accreditors to increase the number of credits that students may transfer in, thus reducing any residency requirements.
- Students must meet the Crown College admission and degree requirements for the academic year in which they are admitted.
- Crown College may extend a scholarship or other tuition/fee reduction to students at its discretion.
- Students are required to submit an official transcript from Argosy University in order to complete the transfer of applicable credit.
- Argosy University and Crown College shall review and update the Course Transfer Guide as necessitated by curriculum changes by either party.

Confidentiality

Any information shared between the parties which by their nature should be reasonably understood by the receiving party as confidential or proprietary information, shall remain confidential, to the extent permitted by law.

Marketing

Argosy University and Crown College will work together to promote this Agreement to the participants, which may include on-site events and distribution of marketing materials. The parties may utilize each other's trademarks in connection with promoting the Agreement, provided Crown College pre-approves such use; neither party shall gain any right, title or interest in any name or trademark of the other party.

Crown College will provide both a toll-free number and email address for student inquiries that may be included in promotional materials, advising sheets and the like produced by Argosy University. In addition, Crown College will prepare its Admissions and Financial Aid staff with information about this Articulation Agreement so that Argosy students can apply with ease and transfer expeditiously to Crown College University.

Termination and Modification

This Agreement is effective upon the date of the last signature and shall remain in effect for one year. Thereafter, this Agreement shall automatically renew for additional one year term(s) unless either party provides sixty (60) days written notice prior to the end of the current term to the other party of its intent to not renew. In addition, either party may terminate this Agreement for any reason, or no reason, by providing thirty (30) days written notice to the other party. This Agreement is subject to change or modification by mutual written consent between the parties. Any provisions of this Agreement which remain to be performed or by their nature would be intended to be applicable following the expiration or termination of this Agreement shall survive the expiration/termination of this Agreement. This Agreement will terminate automatically in the event that either party fails to maintain its accreditation status.

Notice

Any notice provided for or permitted under this Agreement shall be treated as having been given the next business day after being sent by nationally recognized commercial overnight courier or three business days after being postage prepaid by certified or registered mail, return receipt requested, to the party to be notified or upon receipt if delivered in person. Notices will be sent to the addresses set forth in this Agreement or such other address as may be provided from time to time.

By signing below, each party acknowledges its agreement with the terms and conditions of this Agreement and each signatory represents and warrants that he/she is authorized to sign on behalf of his/her organization to all the terms and conditions of this Agreement. This Agreement and any attachments constitutes the full and complete understanding and agreement of the parties hereto with respect to the subject matter hereof and supersedes all prior negotiations, understandings and agreements between the parties related to the subject matter hereof.
