Statements and tax are due annually on or before March 1st. Effective July 1, 2010, all authorized insurers must now file MONTHLY Premium Tax Statements for gross premiums reported during the month (HRS §§ 431:7-201 and 202). The monthly statement and any applicable payment shall be due on or before the 20 day of the calendar month following the month in which the taxes accrue (2010 Session Laws of Hawaii – Act 22).
