Qualified Jurisdictions

Pursuant to Hawaii Revised Statutes §431:4A-101(e)(3), the Insurance Commissioner is required to publish a list of qualified jurisdictions under which an assuming insurer licensed and domiciled in a qualified jurisdiction is eligible to be considered for certification by the Commissioner as a certified reinsurer.

Qualified Jurisdictions include:

- Bermuda
- France
- Germany
- Ireland
- Japan
- Switzerland
- United Kingdom
