## **Reciprocal Jurisdictions**

Pursuant to Hawaii Revised Statutes (HRS) §431:4A-101(g), the Insurance Commissioner is required to publish a list of reciprocal jurisdictions.

The Commissioner's list includes any reciprocal jurisdiction defined under HRS sections 431:4A-101 (f)(1)(A) and 431:4A-101 (f)(1)(B).

- HRS §431:4A-101 (f)(1)(A): A non-United States jurisdiction that is subject to an in-force covered agreement with the United States, each within its legal authority, or, in the case of a covered agreement between the United States and European Union, is a member state of the European Union.
- HRS §431:4A-101 (f)(1)(B): A United States jurisdiction that meets the requirements for accreditation under the NAIC financial standards and accreditation program.

The Commissioner also accepts reciprocal jurisdiction included on the <u>NAIC List of Reciprocal</u> Jurisdictions.
