I. Roll call, Quorum, Call to Order, Public Notice – HRS § 92-3  
Open Meetings

Chair Haik called the meeting to order at 10:01 a.m. HST.  
Chair Haik clarified that anything presented at the meeting is public record.

Greg Misakian, who identified himself as President of Kokua Counsel and a member of various boards provided public comment, noting that insurance prices are impacting Kokua Counsel constituents, and that hurricane insurance is one element and not the predominant element in insurance spikes at condominiums; deferred maintenance is a major factor in prices. Misakian asked if data could be provided on condominium insurance details.

- II. The Board will listen to the presentations from Guy Carpenter and AON Reinsurance Solutions regarding the Request for Proposal (“RFP”) dated November 8, 2024, for services to help HHRF stabilize Hawaii's home insurance market.

AON representatives provided a presentation on AON's proposal. Board members engaged in questions and answers with AON's representatives.
