§ 92-3 Open Meetings.

II. Discussion and decision-making on Board testimony for Legislative bills and Governor's messages from the 2025 Legislative session on the following

measures:

The HHRF may convene an executive session pursuant to HRS section 92-5(a)(4) to consult with the HHRF's attorney on questions and issues pertaining to the HHRF's powers, duties, privileges, immunities, and liabilities.

At approximately 10:36 a.m., Mr. Han requested that the Board go into Executive Session so he may advise the members as to the legal implications of these measures. Mr. Nonaka made a motion to go into Executive Session, seconded by Mr. Bump. (1:08/1:03:27)

- A. <u>SB1044</u> RELATING TO THE STABILIZATION OF PROPERTY INSURANCE. Expands the powers of the Hawai'i Property Insurance Association and reactivates the Hawai'i Hurricane Relief Fund to help to stabilize the property insurance market in the State. Requires the Insurance Commissioner to conduct a study. Appropriates moneys.
  - At approximately 11:19 a.m., Mr. Nonaka made a motion to submit testimony with comments, seconded by Mr. Bump, and unanimously approved (42:43/1:03:27)
- B. SB804 RELATING TO INSURANCE FOR HAWAII CONDOMINIUM PROPERTIES. Requires property insurers to offer discounts on a condominium association's annual insurance premium if the association adopts specific risk mitigation upgrades or develops comprehensive disaster response plans. Requires property insurers of condominiums to base premium increases on actuarial justifications that reflect actual risk reduction resulting from upgraded fire safety improvements installed in conjunction with a building fire and life safety evaluation. Requires property insurers of condominiums to justify premium increases above 10%. Requires property insurers of condominiums to publicly report premium increases each year. (SD1)
