NOTICE OF HEARING

Pursuant to Hawaii Revised Statutes ("HRS") section 431:10C-410 and section 91-9.5, notice is hereby given that the Insurance Division ("Division") will hold a public hearing on May 29, 2025 at 9:00 A.M. in the Princess Likelike Conference Room, 3rd Floor, King Kalakaua Building, Department of Commerce and Consumer Affairs, 335 Merchant Street, Honolulu, Hawaii 96813, to hear all persons interested in AIPSO Filing No. HI 25-01 which was submitted by AIPSO to the Division on behalf of the Hawai'i Joint Underwriting Plan ("HJUP").

The purpose of the filing is to reflect the changes necessary after a review of experience for calendar/accident years 2020 through 2022 for CPAI private passenger risks through the HJUP which produced an overall rate level decrease of -21.6% and a proposed \$764 CPAI rate.
