Continue Discussion/Revisions To Current Report Form

The EO provided a draft of a revised form based on the Committees recommendations made at their last meeting.

Dr. Fleming suggested that on page 6 where it says Lab and clinical nursing credits required, that we somehow split lab and clinical simulation. Also on page 6, Faculty to Student Ratio should also be split because the faculty to student ratio is different for clinical and different for labs.

The EO stated she wants the Committee to consider using a form similar to the "Faculty Form" that Missouri uses instead of asking for resumes.

# Amendments to HAR Chapter 89

The Committee deferred discussion on the following topics.

- Distance/Online Prelicensure Nursing Programs -The Committee will use draft provided at the January 8, 2015 meeting as a reference;
- Temporary License of MEPN Students -May require a law and/or rule amendment to issue only a temporary license to MEPN students;
- National Accreditation and/or Board Approved Nursing Programs -The Committee is considering not accepting nursing programs that are not nationally accredited even though they are state board approved. This would be applied only to exam applicants;
- Foreign Educated English Proficiency MELAB Examination The Committee will review language in Nurse Licensure Compact (NLC);
- Limiting the Number of Times Exam Candidate Allowed to Take NCLEX-The Committee discussed the number of times a candidate should be allowed to take the NCLEX and determined 3-5 times would be acceptable. The EO will check with NCSBN if they have a list of other states who limit the number of times a candidate is allowed to take the NCLEX. The Committee deleted this item as it is in the current draft of the proposed amendments to HAR Chapter 89;
- Annual Pass Rate: 90% of National Pass Rate (NPR) vs. No Percentage of NPR The Committee is considering no percentage of the NPR for

Hawaii nursing programs;

- Probation of Hawaii Nursing Programs for Non-Compliance of Nursing Laws/Rules and/or Pass Rate Below National Standards – The Committee reviewed information provided by Ms. Daub from the Oklahoma board; and
- Ratios Committee will be reviewing the ratios allowed for direct supervision of students to determine if clarification is needed in HAR §16-89-45(i)(2).

The Chair stated she is not familiar with Visa Screen.

The EO stated she does not know what is involved in a Visa Screen, but CGFNS does a course by course comparison. The EO asked the DAG if based on the rules and regulation can the ICHP certificate be accepted in lieu of the CGFNS report?

The DAG was not present to respond.

The Chair clarified this applicant would like us to consider granting a license by endorsement in lieu of the requirement for a foreign graduate.

# **Mignonne Pierre**

The EO stated there is a letter from Mr. Romulus from Transnational Law Center stating that the ECE report should be recognized and that his client should not have to pay for a CGFNS report.

Ms. Daub stated we don't have enough information on the ECE report to consider it and we are still investigating other credentialing agencies.

The Chair wanted to address the DAG on how to proceed.

The DAG was not present to respond.

The EO stated since the DAG is not present to provide guidance, the response would be that right now the Committee is investigating other credentialing agencies, however at this time only CGFNS is a Board approved credentialing organization.

Upon a motion by the Chair, seconded by Dr. Fleming, it was voted on and unanimously carried to defer the application of Mignonne Pierre's for insufficient evidence on ECE to accept its evaluation and that a CGFNS report is required.

# May Pabelonio

The EO stated she has deficiencies on her CGFNS report.

Ms. Napoleon stated her hours in Medical Surgical are very limited, in fact all her hours in the core areas are low.

Dr. Fleming stated it appears her training was very uneven. She has more training in "other" areas then she does in general nursing training.

Upon a motion by the Chair, seconded by Dr. Fleming, it was voted on and unanimously carried to defer the application of May Pabelonio for not meeting the education requirement.
