<u>2016 NCSBN Discipline Case Management Conference, June 6-8, 2016, Norfolk, Virginia</u>

The DAG provided a written report on the NCSBN Discipline Case Management Conference and reported briefly on the conference.

The DAG stated the conference included discussion in the following:

Board Member Terms Amended Due to Passage of Act 9, SLH 2016 (HB 2332, HD1) – "Revised" Amended Terms

The EO provided a revised list of the Board member's terms.

2016 Legislature – Status Report

The EO reported on the following bills:

SB 2861, SD2, HD1 – Relating to the Joint Formulary Advisory Committee (Act 92, SLH 2016 Governor signed into law on 6/21/16)

The Board was provided with a copy of Act 92 that repeals the Joint Formulary Advisory Committee and allows the Board of Nursing to be the sole authority that determines the exclusionary formulary for qualified advanced practice registered nurses with prescriptive authority.

SB 2672, SD1, HD1 – Relating to Advanced Practice Registered Nurses (Act 183 SLH 2016 Governor signed into law on 7/1/16

The Board was provided with a copy of Act 183 that amends various statutes to clarify the role of advanced practice registered nurses with regards to their authority and participation in the health care system. Amends definitions in the statutes to conform with the duties and responsibilities of advanced practice registered nurses.

The EO reported that one of the amendments allows APRNs to certify death and that she has been in contact with the Department of Health, Vital Records Section, who want to start training APRNs and that more information should be forthcoming.

HB 1756, HD3, SD2 – Relating to Nursing (Criminal Background Checks) (Act 97 SLH 2016 Governor signed into law on 6/21/16)

The Board was provided with a copy of Act 97. This bill requires submittal of electronic fingerprints for criminal history record checks from nurse licensure applicants and nurse licensure renewal applicants starting July 1, 2017. It authorizes the Board of Nursing to conduct investigations of applicants for licensure, renewal, and reactivation, request criminal history records of qualified applicants, and request criminal history records of persons issued licenses.

The EO reported that a copy of the Act was also sent to the Criminal Justice Data Center so they can in turn inform the FBI of this new requirement starting July 1, 2017 for initial licensure, reinstatement, reactivation and restoration, and starting with the June 30, 2019 renewal period if you were licensed prior to July 1, 2017. She stated that this bill was written so it will allow the Professional and Vocational Licensing Division to break up the approximately 25,000 nurses into three groups with the first group that will be required to do the Criminal Background Check with the 2019 renewal, the second group with the 2021 renewal and the third group with the 2023 renewal.

The Vice Chair asked if we know what the cost will be?

The EO stated that based on her research she estimates the cost at around \$80.00 which is to be paid by the applicant.

HB 2707, HD1, SD2, CD1 – Relating to Medical Marijuana

This bill was transmitted to the Governor's Office on May 5, 2016 but no word on whether it has been approved.

HB 2233, HD2, SD1, CD1 – Relating to Health Care Professionals (Act 115, SLH 2016 Governor signed into law on 6/22/16)

The Board was provided with a copy of Act 115. This bill requires every physician, physician assistant, advanced practice registered nurse, and naturopathic physician to provide their personal email address to the licensing authority for the purpose of public health and safety.

The Chair asked what does that mean, "for the purpose of public health and safety"?

The EO explained that originally it was related to the Zika virus, and required all healthcare professionals to take course(s) on the virus, but the bill was revised so that the Department of Health will be able to contact healthcare professionals by email with information in the event of a health crisis.

Amendments to Title 16, Chapter 89 - Status Report

The EO reported she is still proofing the draft and with the passage of Act 92, she will also be removing any reference to the Joint Formulary Advisory Committee.

Continuing Competency Program

<u>Does Certification by one of the following organizations meet one of the learning</u> activity options or the exemption?

The EO stated that she is getting a lot of inquiries pertaining to Board recognized certifying organizations for the national certification exemption and asked if anyone of the following organizations who offer a national certification would meet the Board's requirements:

- International Association of Forensics Nurses ("IAFN")
- American Holistic Nurses Credentialing Corporation (AHNCC)
- American Organization of Nurse Executives (AONE)

The Chair asked if AONE certifies individuals?

Ms. Kodama stated yes, she has certification from them in Leadership and Management in Nursing.

The EO asked if there is an exam and continuing education requirements?

Ms. Kodama stated yes, there are several exams and continuing education requirements.

The Chair suggested referring this to the Education Committee so they can review the requirements for certification to see if they are comparable to other certification requirements.

Mr. Joslyn clarified you would be looking at this as an exemption, not a learning activity.

The Chair stated yes, certification is an exemption.

The EO stated that perhaps the Practice Committee should look at criteria for national organizations for national certification so that these types of organizations or nurses can determine if they meet the Board's criteria instead of the Board reviewing every single organization, especially if the Board is looking at criteria such as an exam and continuing education requirements to maintain the national certification.

Mr. Joslyn stated the Practice Committee can look at these, but he really thinks the Education Committee should review these further when it comes to these administrative type certifications.

The Chair stated the Education Committee can review them and refer to the Practice Committee if they have any questions..

Mr. Joslyn stated that sounds appropriate.

The Board, by consensus, referred this matter to the Education Committee for their review and recommendation.

Revisions to Nurse Exam Application – Effective July 1, 2016 and Procedure for NCLEX exam

The EO stated the application for nurse license by exam has been amended to require all applicants for the NCLEX to submit a legible copy of a government issued identification with the individual's picture and date of birth and social security card. This is a result of instances where a candidate for exam shows up at the exam site with an ID that does not match the name on the application. In some of these instances, the candidate had a name change or misspelled their name on the application. Pearson Vue will not allow anyone to sit for the nurse license exam unless they can show a valid picture ID and the name matches the name we, the licensing authority, approved them for.

She stated as for the date of birth and social security card, we have had allegations of identity theft which are currently under investigation. We are hoping that these additional documents will prevent applicants who attempt to procure a license by exam through fraud.

Ms. Daub inquired about the processing of applications. She stated the school sends letters to the LB that these students listed have met the requirements for graduation. The student submits the application and pays the application fee; can they then go online and register to take the exam, or do they need to wait.

The EO stated the normal process is the student submits their application, fees, etc., once approved to sit for the exam, they will receive a notice from our Licensing Branch ("LB") saying they are approved to take the NCLEX. They then register to take the exam. Once they register with the testing service, they are placed on a list, the testing service sends that list to Hawaii and if we have approved them to take the exam, they are made eligible and the testing service sends them their ATT. So if they register to take the exam, but have not gotten approval from LB, they will not receive an ATT from the testing service. Now if they pass the exam, but LB has not received a final transcript showing their degree was conferred, they will not be issued a license.

The Vice Chair stated regarding the final transcript showing a degree conferred, LPN applicants in an ADN program are not going to get that.

The EO stated they would submit evidence of completion like a certificate of achievement.

The EO also stated that the amended application took effect on July 1, 2016 and that LB was instructed to inform applicants who signed their application after July 1, 2016 to complete and comply with the additional document requirements. Also, Hawaii nursing programs were sent a memo and a copy of the amended application and instructions/requirements.

How to be an Effective Participant in Meetings – FYI

The Board was provided with an article from Balanced Living on how to be an effective participant in meetings for their information.

Hawaii State Center for Nursing:

Ms. Reichhardt stated she first wanted to thank the Board for their support during the legislative session they had a really great year this session and the support from the Governor and the Legislators was very significant.

The Chair also thanked Ms. Reichhardt for all her hard work.

Ms. Reichhardt reported she has received questions regarding the legislative activity this past session and also looking forward to the next year. One area was the criminal background checks, there was a question if nurses licensed in another state that requires criminal background checks, if their criminal background check and fingerprinting for that state will transfer for Hawaii. Another question pertaining to the APRN bill that included dispensing of non-controlled substances, the question was if Hawaii would like to consider dispensing of controlled substances by APRNs as well. Ms. Reichhardt stated her question specifically is related to the national efforts to reduce opioid dependency, abuse and deaths. The argument that she has heard, is that some of our population lives in very remote places and ensuring access to care for those patients is a significant and justifiable consideration. Everyone needs full access to care. Lastly, at their Advisory Board Strategic Planning meeting on May 21, 2016 one of the priorities they identified is a very strong interest to improve the nursing workforce survey response. We currently have about a 33%-39% response rate. We are looking at legislative activities to support improved survey response rate. Ms. Reichhardt stated she would like to call a meeting to talk about what the barriers and opportunities are.

The Chair asked if Ms. Reichhardt could clarify what she means by "legislative activities".

Ms. Reichhardt stated some states have mandatory nursing workforce surveys with licensure. So we need to work together to figure out what the avenues are and potential options.

The Chair stated we certainly can discuss that but unless there has been dramatic changes from the Board members, we have not been in favor of mandating a workforce survey.

Ms. Reichhardt stated yes, and with that she would like to work with the Board on how they can improve the workforce survey response rate without having it tied to licensure. Another topic related to continued competency, at the May 21, 2016 meeting they identified an interest in the HSCFN continuing advocacy of awareness of continuing competency and they thought that National Nurses week of 2016 would be a good time to launch a large awareness campaign. She wants to make sure that any efforts the HSCFN does is consistent with the efforts of the Board of Nursing. Ms. Reichhardt also provided a handout to the Board related to the Academic Progression in Nursing program. The Academic Progression in Nursing program worked with all of the schools of nursing in the state to identify pathways for academic progression. It starts from when you obtain a high school diploma but it also considers if you already have an LPN or an ADN. We thought it would be a nice tool to share with the Board considering the continued competency learning activity options related to academic progression. Finally, in the past month or two we have had some states be contacted by NCSBN because

they are interested in doing nursing workforce research and they are partnering with the action coalitions. In Hawaii the HSCFN is the action coalition, but she has not heard anything yet from NCSBN.

The EO asked if the handout she provided today related to the Academic Progression in Nursing will be posted on the HSCFN webpage?

Ms. Reichhardt stated it is not yet posted on their webpage. They are actually looking to have it posted in two different mechanisms. One is to just post it where it can be printed. The other is to have a drop down mechanism, so say you are an LPN, you click on the drop down box and it will show you the progression, and flex to that persons status and level of education. Also, once it is posted online, they would like it to link to each school of nursing the person is interested in.

The Board reviewed information from the Center for Online Education regarding progression in nursing through online education. The information can be found at www.onlinecolleges.net.

American Holistic Nurses Association (AHNA) – Nurse Practice Act Analysis Summary December 2015

The Board reviewed information from American Holistic Nurses Association (AHNA) regarding the Nurse Practice Act Analysis Summary December 2015. The publication describes how other states have recognized the holistic nursing practice.

The Board by consensus referred the information to the Practice Committee for their information and review.

CMS Requirement of Physician Supervision of CRNAs – Hawaii an "Opt-in" State

Mr. Joslyn led the discussion on the publication titled "Fact Sheet Concerning State Opt-Outs and November 13, 2001 CMS Rules". Mr. Joslyn stated in the year 2000 the president of the state association approached then Governor Lingle regarding this and at that time Governor Lingle said "no". Since that time, the association decided not to pursue it, and has discussed it with the Hawaii Hospital Association. This is ultimately a billing issue, what Medicare requires for billing. If the Board would like to further look at this, that is fine, however because we are not a critical access state, I don't feel at this point it is worth the fight to make it happen. Many of the states that have adopted this are rural community hospitals, but I think we would have a very hard time getting this through.

The EO asked Mr. Joslyn if he feels this is a barrier to APRN practice?

Mr. Joslyn stated he does, but he does not feel it is worth the fight.

The Chair stated unfortunately at this time CMS is the biggest barrier to APRN practice.

Mr. Joslyn stated it is and clarified that for the purpose of reimbursement, CMS will only reimburse a CRNA for Medicare patients with some sort of supervision by a physician and that it has nothing to do with liability.

Fact Sheet: New Steps to Reduce Unnecessary Occupation Licenses

The Board reviewed a publication from The White House, Office of the Press Secretary titled "Fact Sheet: New Steps to Reduce Unnecessary Occupation Licenses". The publication talks about how occupational licensing has risen from less than 5 percent in the early 1950s with the majority of the growth coming from an increase in the number of professions that require a license rather than composition in the workforce.

"Scope of practice: How can we expand access to care" – a POLITICO Pro Health Working Group Report

The Board reviewed an article from POLITICO titled "Scope of practice: How can we expand access to care". The article talks about who can practice what kind of medicine, in what settings and under what type of physician supervision, if any.

Scope of Practice Laws and Anesthesia Complications: No Measurable Impact of Certified Registered Nurse Anesthetist Expanded Scope of Practice on Anesthesia-related Complications

The Board was provided with an article titled "Scope of Practice Laws and Anesthesia Complications: No Measurable Impact of Certified Registered Nurse Anesthetist Expanded Scope of Practice on Anesthesia-related Complications" for their review and information.

Are non-bedside RN's required to be supervised or evaluated by someone with a nursing license?

The Board reviewed an email inquiry that asked the following question:

"Are non-bedside registered nurses required to be supervised or evaluated by someone with a nursing license?"

The Chair stated this may have to do with the Joint Commission and that they require that nurses be supervised by nurses. For example if you have nurses in a clinic you cannot have a social worker supervising them. However this has nothing to do with the Board.

After a brief discussion, the Board by consensus determined that supervision/evaluation of a non-bedside registered nurses is not specifically addressed in the nurse practice act.

NCSBN Proposed Standards

- Reporting of Disciplinary Actions by Boards of Nursing
- Primary Source Verification of Licensure by Endorsement

The Board received a Consensus Body Ballot from NCSBN that asked the Board to vote on the two proposed standards above.

The vote does not commit the Board to adopt these standards, but rather express their opinion on the efficacy of such a standard for the regulation of nurses.

The Board by consensus votes "yes" on both standards.

§457-7 Registered nurses; qualifications; licenses; fees; title; existing licensed nurses; verification of licenses; eligibility. (a) An applicant for a license to practice nursing as a registered nurse shall submit an application on a form prescribed by the board and shall provide written evidence that the applicant has completed a nursing program approved by the board.

- (b) Licenses shall be granted either by:
- (1) Examination: The applicant shall be required to pass a written examination in nursing subjects as determined by the board. Upon the applicant's passage of the examination and compliance with the applicable requirements of this chapter and the rules of the board, the board shall issue to the applicant a license to practice nursing as a registered nurse; or
- (2) Endorsement: The board may issue a license to practice nursing as a registered nurse by endorsement to an applicant who has been licensed as a registered nurse under the laws of another state, territory, or foreign country if the applicant has an **unencumbered** license and, in the opinion of the board, the applicant meets the qualifications required of registered nurses in this State at the time of graduation. Pending verification of a valid, unencumbered license from another state, a temporary permit may be issued for employment with a Hawaii employer.

§457-12 Discipline; grounds; proceedings; hearings. (a) In addition to any other actions authorized by law, the board shall have the power to **deny**, revoke, limit, or suspend any license to practice nursing as a registered nurse or as a licensed practical nurse applied for or issued by the board in accordance with this chapter, and to fine or to otherwise discipline a license for any cause authorized by law, including but not limited to the following:

(8) Revocation, suspension, limitation, or other disciplinary action by another state of a nursing license for reasons as provided in this section;
