Mr. Mulcahy stated that Mr. Palmer's application for a PCFR license was pending and asked the Board if Mr. Palmer, who was also in attendance, could answer any questions the Board may have. The Executive Officer indicated that additional documentation was needed to support Mr. Palmer's answer to Question #7 on his application, which asks: "Have you ever been convicted of a crime in any jurisdiction that has not been annulled or expunged?"

Mr. Palmer explained that he was informed by the Licensing Branch that his documents had been misplaced and that he was asked to resubmit the information. He indicated that he had complied with this request.

The Executive Officer briefly left the meeting and returned with Mr. Palmer's application file for review and discussion by the Board.

# Executive Session:

At 2:14 p.m., it was moved by Dr. Yates, seconded by Mr. Lau, and unanimously carried to move into executive session pursuant to HRS § 92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS § 26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS § 92-5(a)(1) and (4).

Guest were excused from the meeting room, except for Mr. Palmer.

It was moved by Mr. Lau, seconded by Mr. Ai, and unanimously carried to move out of executive session 2:39 p.m.

Guests returned to the meeting room.

After further discussion and consideration, by consensus of the Board, they voted unanimously to issue Mr. Palmer a <u>conditional</u> license. Mr. Palmer will be required to submit his Certificate of Completion of the Batterer's Intervention Program; he must continue to comply with all of the terms and conditions of his probation in the State of Florida, including the payment of all fines; also, upon successful completion of his probation, Mr. Palmer will be required to submit official verification from the State of Florida to the Board. Mr. Palmer was advised that failure to comply with any of the conditions would result in the revocation of his conditional license.

Mr. Palmer confirmed his understanding and left the meeting.

# Open Discussion/ Announcements:

#### Pango Wrap – Installation

Mr. Tucker summarized the information he had provided to the Board in advance of the meeting regarding the installation of the Pango Termite/Vapor Barrier. He explained that the installation of the product would require a 2-person team to roll out the product and tape the seams.

Mr. Tucker expressed concern over the Board's determination at its previous meeting that a licensed Pest Control Operator ("PCO") may be required to install the product and asked the Board what Stego Industries, LLC ("Stego") could do to be given the determination that Terminesh had been given.

DAG Tam referenced the Board's April 18, 2016 letter to Stego in which it clearly indicated that if the word "termite" or any references to any other pests were removed from sales and marketing materials, the installation of a "vapor barrier" alone would not constitute the practice of "pest control," and therefore, would not require installation by a licensed PCO.

Mr. Tucker explained that Stego will not be changing its marketing materials to delete references to termites and pests as the effort and costs associated with doing so would be too great.

Dr. Yates indicated that Termimesh offered training on the installation of its termite barrier, and asked if Stego had any plans to provide training on its barrier product. Mr. Tucker stated that Stego does plan to provide the appropriate training.

# Executive Session:

At 3:17 p.m., it was moved by Mr. Montalbo, seconded by Mr. Lau, and unanimously carried to move into executive session pursuant to HRS § 92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS § 26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS § 92-5(a)(1) and (4).

It was moved by Mr. Lau, seconded by Dr. Yates, and unanimously carried to move out of executive session at 3:30 p.m.

After careful consideration, the Board voted unanimously to determine that the installation, use, and advertisement of the Pango Termite/Vapor Barrier Product does not appear to fall within the definition of "pest control" as defined in HRS §460J-1. Mr. Tucker and Mr. McCarthy confirmed that its product does not fall within any of the items listed in the definition of "pest control."
