Call to Order:	The Chair called the meeting to order at 8:36 a.m. at which time quorum was established and excused Mr. Duldalao from today's meeting.
Chair's Report:	Announcements/Introductions
	The Chair asked the audience to introduce themselves.

The Chair congratulated Ms. Okawa on confirmation of her appointment to the Board. She also commented on the lovely Senate floor presentation honoring 100 years of nursing regulation in this State.

Approval of the Previous Minutes – March 14, 2017

Conferences/Seminars/Meetings

The Chair called for a motion in regards to the minutes of the March 14, 2017 meeting.

There being no discussion, upon a motion by the Vice Chair, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the March 14, 2017 meeting as circulated.

Executive Officer's Report:

The EO reminded the Board to complete the Disclosure of Financial Interest by the deadline of May 31, 2017 to avoid penalty.

<u>2017 NCSBN Midyear Meeting, March 13-15, 2017, Salt Lake City, Utah</u> Ms. Kodama reported that NCSBN has posted on its webpage video of the speakers from the meeting and encourages everyone to view them. One speaker that she found very interesting spoke about drugs that are no longer detectable because there are so many other components and poisons mixed in the drugs that it gives false readings to drug tests. Another thing that came up is NCLEX will be changing their guidelines, and a lot of the faculties are concerned that their percentages will drop.

<u>2017 NCSBN APRN Roundtable, April 4, 2017, Rosemont, Illinois</u> The EO reported that Ms. Napoleon attended the 2017 NCSBN APRN Roundtable and has provided a written report to the Board.

Ms. Napoleon also reported the main theme of the meeting was about education and certification and they used driver licenses as a metaphor. How we get our license to practice is how we get our license to drive. A lot of the challenges is that people are not necessarily practicing with their education and certification, like in rural communities. There was also a big discussion on what is the difference between a Certified Nurse Midwife and a Women's Health Nurse Practitioner. These videos are also posted on NCSBN's webpage.

<u>Board of Nursing Investigator Training, April 25-27, 2017, Chicago, Illinois</u> The EO reported that RICO Investigator, Joyce Miyashiro will be attending.

> 2017 NCSBN Discipline Case Management Conference, June 12-14, 2017, Pittsburgh, Pennsylvania

The EO reported the DAG and Ms. Napoleon will be attending.

2017 NCSBN Annual Meeting, August 16-18, 2017, Chicago, Illinois

The EO reported that the Chair, Ms. Kodama, Mr. Joslyn and herself will be attending and asked if anyone else was interested in attending to let her know today so that she can apply for funding. Ms. Kim and Ms. Daub stated they are interested in attending.

2017 NCSBN NCLEX Conference, September 25, 2017, Chicago, Illinois The EO reported Ms. Daub will be attending.

2017 Legislature

The EO reported on the status of the following bills:

SB 984, HD1 Relating to Workers' Compensation Physician

The House CPC passed this bill without amendments. It still has a defective date of 2050. It will go back to the Senate where it should go into conference. There were concerns raised previously by the medical industry about including APRNs under the definition of "physician".

HB 912, HD2/SB 401, SD1 Relating to Nursing

These bills allow advanced practice registered nurses to offer care and services to minors and patients in assisted community treatment programs similar to care and services offered by physicians and other health care service providers.

SB 401, SD1 has not been scheduled for hearing on the House side. HB 912, HD2, as of 3/31/17, the Department of Health is still working on clarifying the definition of APRNs with prescriptive authority and who hold a national certification in a psychiatric specialty.

HB 1272, HD1, SD1 Relating to Improving Access to Psychiatric Care for Medicaid Patients

This bill specifies that coverage for telehealth under the State's medicaid managed care and fee-for-service programs includes psychiatric services delivered via telehealth through a behavioral health care manager who is present in a primary health care provider's office. This bill will go back to the House. The House can either accept the SD1 or reject it and it will go into conference committee.

Tracking only

SB 505, SD1, HD2 Relating to Health

This bill establishes procedural and documentary requirements for informed consent to opioid therapy in circumstances that carry elevated risk of dependency, subject to Department of Health administration and monitoring. Establishes limits for opioid and benzodiazepine prescriptions. Clarifies Board of Nursing authority to enforce compliance with Uniform Controlled Substance Act. This has been going back and forth about who is going to develop the informed consent form. This would amend the disciplinary action section of Chapter 457.

Tracking only.

<u>SB 1312, SD2 Relating to Licensure of Certified Professional Midwives</u> The House Health Committee deferred this measure indefinitely.

<u>SB 1129, SD2 Relating to Health</u> The House Health Committee deferred this measure indefinitely.

Amendments to Title 16, Chapter 89 – Status Report of Draft #8

The EO reported we have started the rules amendment process by sending them to the Director's office for review on Monday, April 3, 2017. They were approved and sent to the Legislative Reference Bureau, Department of the Attorney General's Office and copied to the Regulated Industries Complaints Office.

Draft 7 Amendments include, but is not limited to the following:

- Placing a limit (3) as to how many times a candidate may sit for the NCLEX before being required to take a remedial course;
- Allows the Board to require all nurse applicants to obtain an additional background check, including a self-query report from the National Practitioner Data Bank;
- Includes failure to report oneself or the director of nursing, nursing supervisor, peer or colleague, any disciplinary action, termination or resignation of a nurse before conclusion of any disciplinary proceeding as "unprofessional conduct";
- Amends APRN "recognition" to APRN "license"; and
- Allows the Board to conduct a random audit of the renewal of APRNs with prescriptive authority compliance with the continuing education requirement.

Continuing Competency Program ("CCP")

Draft of "Continuing Competency Guidance and Information Booklet for Nurses, Employers and Facilities"

The Board was provided with a draft of the "Continuing Competency Guidance and Information Booklet for Nurses, Employers and Facilities". There is redundancy throughout the booklet because repetitiveness is a good learning tool so that is why it repeats certain information. There was a question about the algorithm that it looks like it is focused on continuing education ("CE").

Ms. Smith stated just for clarification, her understanding is that the algorithm was developed just for certification, not CE.

The Chair stated certification allows an exemption, so contact hours are irrelevant in relation to certification.

Ms. Smith stated on page 18, using the flowchart if you find that your certification does not meet the criteria, you can still use the credits you completed to convert to hours.

The Chair stated the first box of the flowchart states "Start Certificate eligibility Check". However, every time you go to a conference you will get a certificate, but what we are talking about here is "Certification". So that should be changed to say "Start Certification eligibility Check".

The EO asked, what this is saying is even though the certification is not recognized by the Board or not nationally recognized, the CE's that they took to maintain that certification may still count?

Mr. Joslyn stated maybe there should be two algorithms, clarifying that one is a certification and one is not, and have the follow through for CE's.

The Chair stated this first one could end at "yes" the certification meets the criteria, and if its "no", then it can say you have to go back and meet one of the other learning activity options.

The EO stated if you are looking at allowing the CE's they completed as the learning activity option in this case, then this part should be moved to page 20, which is Learning Activity Options, Continuing Education (CE).

Ms. Smith agreed with the EO.

> <u>Joanna Smith – International Board for Certification of Safety Managers – Certified</u> in Healthcare Safety: Nursing (CHSN)

The Board reviewed an email inquiry from Ms. Smith asking whether or not certification related to health care safety will be applicable toward meeting the requirements. Specifically the International Board for Certification of Safety Managers.

After a brief discussion, the Board by consensus would not accept certification from the International Board for Certification of Safety Managers in health care safety as they are not recognized by the Board.

<u>Leilani Wright – Questions on Learning Activity Option "Developing and conducting</u> <u>a nursing education presentation or presentations totaling a minimum of 5 contact</u> <u>hours of actual organized instruction that qualifies as continuing education."</u> The Board reviewed the following email inquiry from Ms. Wright:

"Per the nursing dcaa FAQ on the website, one of the options for continuing competency requirements is: "Developing and conducting a nursing education presentation or presentations totaling a minimum of 5 contact hours of actual organized instruction that qualifies as continuing education." What is the process for approval of a proposed presentation and what are the requirements for determining the number of contact hours that can be offered?"

After a brief discussion, the Board by consensus determined that the language as follows, as shown on page 28 of the "Continuing Competency Guidance and Information Booklet for Nurses, Employers and Facilities" addresses the inquiry:

"If you develop **and** conduct (present) a nursing education presentation or presentations totaling a minimum of five contact hours of actual organized instruction that qualifies as continuing education within the biennium (i.e. July 1, 2017 to June 30, 2019), then this will satisfy one of the learning activity options.

You must be the primary presenter of a first-time presentation.

The presentations must total at least five contact hours of actual organized instruction.

The presentations are delivered in a structured teaching/learning framework to nurses, other healthcare providers, or the public as part of conferences, grand rounds, in-services, seminars, CD-ROM content, internet-based or other e-learning formats, teleconferences, patient/family teaching, or public education.

Repeat presentations of the same material or modifications of the same material, presentations or lectures that were a required part of your job, or presentations for which you served as a panel moderator will **not** be accepted

If you are audited, you will be required to submit supporting documents such as a copy of the presentation outline, abstract, letter accepting your abstract, or letter inviting you to speak as well as evidence that you actually presented the topic (e.g., a thank-you letter on official letterhead)."

The Chair called for a recess at 9:25 a.m.

The Chair resumed the meeting at 9:37 a.m.

Ms. Kawana clarified if her national certification is valid for 5 years, so it spans over 2 renewal periods, can she apply it as an exemption to the continuing competency requirement for those 2 renewal periods?

The Board by consensus determined that as long as the certification remains current beyond June 30 of the renewal year it will count.

Criminal Background Checks – Status Report on Implementation

The EO reported she had a conference call with Fieldprint on 4/3/17. We are hoping to have the fingerprinting up and running within the next month. We do have some applicants who have elected to become licensed effective on or after July 1, 2017 and therefore would need to have their fingerprinting done before July 1, 2017 or they cannot get licensed.

GEPN Student Nurse License

The EO reported that she will have a draft for the Education Committee to review at their next meeting. Upon approval of a final draft of the language to amend the admin rules to issue a temporary license to GEPN students until they complete the GEPN program and receive a nursing degree, the Board will have an opportunity to review and make further recommendations.
