# 2017 Legislature

The EO reported on the status as of May 26, 2017 on the following bills:

## <u>SB 984, HD1, CD1 Relating to Workers' Compensation Physician</u> This bill was transmitted to the Governor's office for his approval/veto.

## HB 912, HD2, SD1 Relating to Nursing

This bill relates to Advanced Practice Registered Nurses; Psychiatric Specialization; Health Care Practitioners; Minors; Assisted Community Treatment; Health Services. It was transmitted to the Governor's office for his approval/veto.

# HB 1272, HD1, SD1 Relating to Improving Access to Psychiatric Care for Medicaid Patients

This bill specifies that coverage for telehealth under the State's medicaid managed care and fee-for-service programs includes psychiatric services delivered via telehealth through a behavioral health care manager who is present in a primary health care provider's office. Takes effect 7/1/2075. (SD1)). This bill did not pass out of conference committee.

## SB 505, SD1, HD2, CD1 Relating to Health

This bill requires prescribing healthcare providers to adopt and maintain policies for informed consent to opioid therapy in circumstances that carry elevated risk of dependency. Establishes limits for concurrent opioid and benzodiazepine prescriptions. Clarifies Board of Nursing authority to enforce compliance with Uniform Controlled Substances Act. Repeals 6/30/2023. (CD1)). This bill was transmitted to the Governor's office for his approval/veto.

## Amendments to Title 16, Chapter 89 – Status Report

The EO asked Ms. Kalani if she received the draft of the rules back from office services. Ms. Kalani said she received a draft back but had to send it back to office services for corrections and that this draft included the recommendations form the Legislative Reference Bureau.

The EO reported that the DAG is also working on her review and that any nonsubstantive corrections will be sent to office services.

Amendments include, but is not limited to the following:

- Placing a limit (3) as to how many times a candidate may sit for the NCLEX before being required to take a remedial course;
- Allows the Board to require all nurse applicants to obtain an additional background check, including a self-query report from the National Practitioner Data Bank;

- Includes failure to report oneself or the director of nursing, nursing supervisor, peer or colleague, any disciplinary action, termination or resignation of a nurse before conclusion of any disciplinary proceeding as "unprofessional conduct";
- Amends APRN "recognition" to APRN "license"; and
- Allows the Board to conduct a random audit of the renewal of APRNs with prescriptive authority compliance with the continuing education requirement.

# Continuing Competency Program ("CCP")

The Board reviewed an algorithm prepared by Ms. Smith to assist a nurse licensee in determining whether his/her national certification exempts them from completing one of the learning activity options under the continuing competency requirement.

Mr. Joslyn stated that he thought the Board previously discussed this to include information that pertains to the nurses' continuing education even though the national certification may not be recognized by the Board, the continuing education completed to maintain the national certification may count towards the continuing education learning activity option.

The EO stated that she will work with Ms. Smith and plans to "update" the continuing competency booklet in July after the renewal period.

## Criminal Background Checks – Status Report on Implementation

The EO reported that so far there hasn't been too many complaints regarding this new license requirement. She stated that due to the renewal period there are some nurse license applicants who wish to be licensed on or after July 1, 2017 instead of receiving their new license now and having to renew the license. These individuals are informed of the fingerprinting requirement that must be completed prior to the issuance of the nurse license.

Ms. Kalani stated that we have received approximately 30 results from nurses who were fingerprinted.

The EO stated that the Board will have to consider how to address further, license applicants who may have to be considered by the Board if an applicant discloses a prior conviction and whether there is a match or no match as a result of the fingerprinting.

Ms. Kodama asked if we anticipate a lot of applicants to have to be considered by the Board?

The EO stated that she does not know but would prefer to be prepared and have a procedure in place.

The Board deferred further discussion on this matter and asked that it be placed on the July 2017 meeting agenda.

## **GEPN Student Temporary Nurse License**

The EO reported that she still has to discuss with the DAG whether or not statutory amendments have to be made in order to implement a temporary license for GEPN students.

## Correspondence

Hawaii is Not One of the Worst States for Nurses

The EO asked Ms. Reichhardt to report on her excellent response to a recent national survey that indicated that Hawaii ranked as the second worst state in the nation for nurses to work.

Ms. Reichhardt cited the following:

Last week Wallet Hub ranked Hawaii as the second worst state in the nation for nurses to work. I disagree.

The Wallet Hub report states there are few nursing job openings in Hawaii. What we know anecdotally, that nurses tend to remain in their positions once they secure them and that nursing is a prestigious career in Hawaii, is validated by our local research.

According to the Hawaii State Center for Nursing's 2015 Nursing Workforce Report, there has been nearly 50 percent growth in the licensed nursing workforce in the state over the past decade and the majority of nurses indicate they intend to remain active as working nurses for at least 10 years showing growth in the workforce and stability in positions held. The UH System Hawaii Industry Sectors report also lists registered nurses as the most in demand occupation in the state.

The Wallet Hub report also notes that Hawaii has the lowest annual nursing salary when adjusted for cost of living. However, looking at salary alone, which Wallet Hub has reported in the past, Hawaii employers compensate nurses at one of the highest rates in the nation and the Hawaii Industry sectors report validates this.

The average nurse salary in Hawaii is 26 percent higher than the national average nurse salary. Employers are ensuring that Hawaii is a good place for nurses to work by accommodating for the high cost of living.

Most importantly, the State of Hawaii has one of the highest rates of nurses in the nation who hold bachelor's degrees in nursing (68 percent). This makes Hawaii a leader in the Institute of Medicine's Future of Nursing recommendation that by 2020, 80 percent of nurses have a bachelor's degree or higher in nursing in order to meet the increasing demands of an evolving health care system.

I can't imagine how we can achieve such great advancements in our nursing workforce, have the highest demand for nurses across all professions, and have the incredible growth in our nursing population, and be the second worst in the nation. Clearly, to me, the opposite is true. Hawaii's nurses are passionate, driven, and a strong component of the healthcare team in Hawaii.

#### Scope of Practice Questions – Ketamine

The Board reviewed the following email inquiry from Dr. Patrick Greiffenstein:

I'm a trauma surgeon in Louisiana conducting a survey of practice patterns in the US pertaining to Ketamine. I searched the online resources for references to the use of Ketamine specifically or at least anesthetic agents by non-CRNA nurses and did not find any in your state's board of nursing webpage.

Could you please clarify for me what the state board policy is on the use of ketamine? Are RNs allowed to administer, titrate, and/or monitor patients receiving ketamine? And if so, can they do so outside of the realm of procedural sedation? (ie. As an adjunct to continuous sedation in ventilated ICU patients or in subanesthetic doses for the treatment of pain)

It was the consensus of the Board that although the Board has no formal policy on nurses administering ketamine and the nurse practice act does not specifically prohibit this drug from being administered by a nurse, only qualified nurses who have received the appropriate education and training and who are carrying out the orders of a licensed physician, APRN, physician assistant, or other practitioner indicated in HRS 457-2 and in accordance with the facility's policies and procedures, may administer ketamine.

In accordance with Hawaii Administrative Rules ("HAR") section 16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and thus is not binding on the Board.

> <u>Position Paper, "Substance Use Among Nurses and Nursing Students"</u> The Board reviewed a position paper titled "Substance Use Among Nurses and Nursing Students". This is a joint position statement of the Emergency Nurses Association and the International Nurses Society on Addictions. It is the position of the Emergency Nurses Association and the International Nurses Society on Addictions that:

- 1. Health care facilities provide education to nurses and other employees regarding alcohol and other drug use, and establish policies, procedures, and practices to promote safe, supportive, drug-free workplaces.
- Health care facilities and schools of nursing adopt alternative-to-discipline (ATD) approaches to treating nurses and nursing students with substance use disorders, with stated goals of retention, rehabilitation, and re-entry into safe, professional practice.
- 3. Drug diversion, in the context of personal use, is viewed primarily as a symptom of a serious and treatable disease, and not exclusively as a crime.
- 4. Nurses and nursing students are aware of the risks associated with substance use, impaired practice, and drug diversion, and have the responsibility and means to report suspected or actual concerns.

Ms. Kim arrived 9:19 a.m.

Inquiry Regarding Emergency/Disasters and Compact License The Board reviewed the following email inquiry from Sheila Deziel of Fresenius Medical Care:

I am a volunteer with the Kidney Community Emergency Response team and we are gathering information on the following items and would appreciate it if you'd take the time to answer a few questions:

- 1. If a nurse licensed in another state is needed to provide dialysis services in an emergency or disaster situation such as a hurricane or earthquake what steps would the nurse need to take?
- 2. Would the nurse be able to complete the process on line?
- 3. Is there any pending legislature moving toward becoming a compact state?
- 4. What is the timeframe one might expect if applying for emergency licensure?

The EO stated that there is a law that may allow for a "waiver" for healthcare professionals who come into the State upon a declaration by the Governor of a State of Emergency but provides that the healthcare professional must be licensed in their domicile state in the profession for which they are practicing. She will double check and report back to the Board at the July meeting.

The Board deferred responding to the inquiry until the information pertaining to licensing laws during an emergency period could be confirmed.

The EO gave a brief status report on the license renewals as follows:

As of May 24, 2017, 940/1,555 APRNs, 1,164/2,984 LPNs and 14,642/27,662 RNs have renewed so far.

<u>Hawaii State</u> <u>Center for Nursing</u>: Ms. Reichhardt reported on the nursing workforce survey. She stated that they have received 10,610 total responses so far, which is 90% of what they had last year and there is still four more weeks to go. They are still recruiting for a nurse researcher, so hopefully that person will take over and do the analysis over the fall.

## Presentations Presentation by Pu'ulu Lapa'au

Mr. Sakai introduced himself and the other members of the staff at Pu'ulu Lapa'au as Ms. O'Neil, Ms. Murphy, Mr. Moses, and Dr. Bjordson. Pu'ulu Lapa'au is a 501c3 non-profit corporation that exists for the purpose of **monitoring** healthcare providers who may get in trouble with issues such as substance abuse, disruptive behaviors, and medical conditions which may indicate that they may not be safe to practice their particular profession. At this time, they presented a Power Point presentation.

Mr. Moses stated he joined Pu'ulu Lapa'au specifically to improve the efficacy of transitioning people with substance use disorders in nursing into the correct care and reentry.

Ms. O'Neil stated she has been with Pu'ulu Lapa'au since 2011 and is a recovering alcoholic with 20 years of sobriety. What she would like to emphasize is that if we are able to help the nurses who have some kind of addiction, whether its drugs or alcohol, there is help for them, but what they do need is strong support.

Dr. Bjordson stated that Pu'ulu Lapa'au services mainly substance abuse disorder and probably half of the people referred to them are by the employer. Their monitoring contracts are usually five years long and very stringent, and their success rates are very good.

Mr. Joslyn asked if they have a facility that someone seeking treatment could walk in to?

Mr. Moses stated they can contact Pu'ulu Lapa'au and then we could see about getting them to the proper physician or treatment, or at least getting them to our peer support group as a place to start. All the treatment occurs separate from us because we cannot monitor and treat at the same time. Our function is truly monitoring.

The EO stated the Board generally does not get involved in the investigation process, that would come under the Regulated Industries Complaints Office ("RICO"). She was wondering if Pu'ulu Lapa'au has ever been in contact with them?

Dr. Bjordson replied yes, a fair number of times.

The DAG commented that a large component of the Hawaii Medical Board's relationship with Pu'ulu Lapa'au is for new applicants. If there is an issue with a new applicant, what the Medical Board will often do is issue a conditional license, with the condition that they participate in a 5-year contract with Pu'ulu Lapa'au.

Jared Redulla, Department of Public Safety, Narcotics Enforcement Division ("NED") -Presentation on Statutory Requirements of Reporting Theft/Missing Controlled Substances and NED Reporting Form.

Mr. Redulla provided the Board with an Information Sheet and copy of a Controlled Substance Incident Report form and a Controlled Substance Inventory form. Mr. Redulla cited some key components from the Information Sheet as follows:

- <u>Examples of Reportable Theft or Loss</u> Any diversion, theft, burglary, missing inventory, missing drugs during counts, damaged stock resulting in missing/unaccounted for controlled substances;
- <u>State Law Hawaii Administrative Rule 23-200-12</u> Theft or Loss must be reported to the Narcotics Enforcement Division ("NED") within 24 hours of having actual knowledge of theft or loss of controlled substances. Furthermore, a written report must be submitted to the NED within three business days;
- <u>Federal Law 21CFR 1376.1</u> Any Theft and any SIGNIFICANT loss must be reported to the local DEA field office within one business day. "Significant" depends on many factors (Note: Best to report ANY theft/loss);
- How to Report

State reporting requirements: within 24 hours – phone call to the NED office (808) 837-8470 or after hours (808) 363-0576. Within 3 business days – submit NED form "Controlled Substances Incident Report", or submit completed copy of DEA Form 106, or write a detailed letter explaining the facts and circumstances surrounding the theft or loss of controlled substances including who, what, where, when, how and why. DEA reporting requirements: within one business day, go to website: <u>deadiversion.usdoj.gov</u>. Look for forms and electronically fill out DEA Form-106. Print a copy for your records.; and

Violations for Non-Reporting • Violation for non-reporting of theft and loss of controlled substances can be treated as a felony under State Law. Furthermore, both the NED and DEA may take action against the registrant's controlled substance registration Ms. Kodama asked if the pharmacist has to call in? Mr. Redulla stated number one is you would want the registrant to call. If you are an APRN-Rx and this is your drugs that are missing, you are the registrant, you need to call. If you are the nurse manager on duty or nursing director and you are responsible for that stock of medication, then you need to call. If you are the practitioner or physician, you need to call. Typically, in a large hospital it is the pharmacist or pharmacy manager that calls because the drugs fall under the responsibility of the hospital pharmacy. However, many institutions have policies and procedures in place to deal with theft or loss. The EO asked if violations for non-reporting is only against the registrant? Mr. Redulla replied the regulated person or institution is held responsible. Applications: The Board moved into Executive Session.
