Call to Order: The Chair called the meeting to order at 8:32 a.m. at which time guorum was

established and excused Ms. Okawa from today's meeting.

Chair's Report: Announcements/Introductions

The Chair asked the audience to introduce themselves.

Approval of the Previous Minutes – September 7, 2017

The Chair called for a motion in regards to the minutes of the September 7, 2017 meeting.

There being no corrections, upon a motion by the Vice Chair, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the September 7, 2017 meeting as circulated.

Vice Chair's Report:

No report.

Executive Officer's Report:

Conferences/Seminars/Meetings

2017 NCSBN Leadership & Public Policy Conference, October 11-13, 2017, New Orleans, Louisiana

The EO reported the Vice Chair and herself will be attending.

NCSBN BON Investigator Training, October 24-26, 2017, Chicago, Illinois
The EO reported that Karen Axsom, RICO Investigator (Hilo Office) and Billy Chin, RICO Investigator (Oahu Office) will be attending.

<u>Hawaii State Center for Nursing Community Conversations 2017: Workforce Data, October 10, 2017, Queen's Conference Room</u>

The EO asked if anyone was interested in attending they may contact the Hawaii State Center for Nursing.

<u>Hawaii's 2017 Health Care Leadership Conference, November 2-3, 2017, Royal Hawaiian Hotel</u>

The EO reported the Chair, Ms Kodama and Ms. Boyer will be attending the second day of this conference.

2018 Legislature

The EO reported that there may be a bill to amend the insurance regulations to include a more general definition for "health care provider" and to delete references to specific health care professions. This amendment would still allow APRNs to be reimbursed for services that fall within their scope of practice.

When a final draft is available, the Board will be able to review.

Amendments to Title 16, Chapter 89 – Status Report

The EO reported that she is working on the Small Business Regulatory Review Board ("SBRRB") memo.

Amendments in this draft include:

- Placing a limit (3) as to how many times a candidate may sit for the NCLEX before being required to take a remedial course;
- Allows the Board to require all nurse applicants to obtain an additional background check, including a self-query report from the National Practitioner Data Bank;
- Includes failure to report oneself or the director of nursing, nursing supervisor, peer or colleague, any disciplinary action, termination or resignation of a nurse before conclusion of any disciplinary proceeding as "unprofessional conduct";
- Amends APRN "recognition" to APRN "license";
- Allows the Board to conduct a random audit of the renewal of APRNs with prescriptive authority compliance with the continuing education requirement; and
- Technical, non-substantive amendments for clarification.

Nursys – Status Report

The EO reported that she will be having a conference call with NCSBN's staff and the Department's IT people about Hawaii's participation in Nursys and will provide a status report at the November meeting.

Temporary Nurse License

The EO reported that she is still reviewing this matter and will have to meet with the DAG.

Correspondence

<u>NCSBN</u>

➤ Legislative Update 9/15/17

The EO reported that there were a couple of bills out of California that included the enactment of legislation regarding APRNs ordering buprenorphine. Another bill that is waiting for the Governor's approval makes changes to the CE requirements and disciplinary measures and provides for an intervention program to identify and rehabilitate RNs with impaired competency due to substance abuse or mental illness. Also requires the California Research Bureau to report to the Legislature on the extent to which employers voluntarily report disciplined nurses to the Board.

Bills that were introduced:

Michigan – Join the enhanced NLC; expand the scope of practice of CRNAs to allow independent practice and prescribing; Wisconsin – Allows the recreational use of marijuana as well as medical use for the alleviation and treatment of debilitating conditions; and US H – Allows greater flexibility for all four APRN roles to provide medication-assisted treatment for opioid use

➤ Legislative Update 9/22/17

The EO reported that Illinois enacted a bill that would extend the sunset on the Nurse Practice Act until 2028 and made changes related to the definitions, APRN title, oversight and delegation and scope of practice for RNs and LPNs. The bill also grants full practice authority to CNMs, CNSs, and CNPs, requires accreditation for program approval beginning in 2022 and requires a remediation course in order to re-apply for a license if the applicant has failed to pass or take the NCLEX within three years after their initial application.

Bills that were sent to the Governor for approval:

California – Extends the sunset of the Vocational Nursing Board to 2021, requires certain reports to be submitted to the Legislature and replaces the current EO position with one to be appointed by the Governor; and authorizes the board to either hear a petition regarding the reinstatement of a license or to assign the petition to the Office of Administrative Hearings;

Bills that were introduced:

Wisconsin – Ratify and enter Wisconsin into the enhanced NLC.

Veterans Affairs APRN Full Practice Authority Implementation

The EO reported that the Department of Veterans Affairs (VA) is continuing the implementation process of their APRN Full Practice Authority Final Rule. As part of this process, VA has asked NCSBN to share the attached letter with all boards of nursing. As the letter states, the form on the third page of that document will accompany license renewal applications for qualifying APRNs (nurse practitioners, clinical nurse specialists, and nurse midwives) that work at VHA facilities that have adopted the full practice authority policy. While the form is intended for APRNs renewing licenses in restricted practice states, we anticipate that boards of nursing in full practice authority states may receive it as well.

NCSBN previously distributed a memo on VA APRN full practice authority to all BONs explaining the legal justification for the VA's regulation. That memo is also attached to this email for your reference. If you have any questions or concerns about the letter or the new form, please let me know.

VA has committed to working with NCSBN and its member boards to address concerns by boards of nursing as they implement this regulation.

The following is a summary of the VA notification letter:

- 1. Effective January 13, 2017;
- 2. VA authorized to grant full practice authority to the APRN when they are acting within the scope of their VA employment as a CNP, CNS or CNM;
- 3. CRNAs were not included under the final rule;
- 4. The final rule established the professional qualifications an individual must possess to be appointed as an APRN within the VA, the criteria under which VA may grant full practice authority to an APRN and defined the scope of full practice authority for each category;
- 5. The services provided by an APRN under full practice authority in VA are consistent with the nursing profession's standards of practice for such role;
- 6. The purpose of the final rule is to increase veteran's access to health care by expanding the pool of qualified health care professionals who are authorized to provide primary health care and other related health care services to the full extent of their education, training, and certification, without clinical supervision of physicians, while maintaining the patient-centered, safe, high-quality health care that Veterans receive from VA:
- 7. VA is exercising Federal preemption of state nursing licensure laws to the extent such state laws conflict with full practice authority granted to VA APRNs while acting within the scope of their VA employment...only preempts State law for VA employees practicing within the scope of their VA employment so infringement upon State authority would be limited i.e. APRN will still need to possess a license from a state licensing board in one of the recognized APRN roles and full practice authority of an APRN is subject to the limitations imposed by the CSA and thus that APRNs state licensure on the authority to prescribe, or administer CS;
- Veterans Health Administration's policy that an individual CNP, CNS, or CNM granted full practice authority will be recognized as a licensed independent practitioner and be clinically privileged in accordance with VA's clinical privileging process.

RICO Advisory Committee

The Board reviewed the "confidential" list of the nursing advisory committee members. This matter was deferred towards the end of the meeting for further consideration.

The American Association of Nurse Attorney's Position on Statutes of Limitation & Retained Jurisdiction in Nursing and NCSBN's Response

The TAANA wrote a "position paper" which advocated the imposition of (1) a statute of limitations on state boards of nursing disciplinary actions and (2) limitations on the ability of a BON to take reciprocal disciplinary action against a licensee based on actions by another state BON.

The NCSBN responded to TAANA's position paper clarifying the role of the BON (protection of the public) and its delegated authority to administer enforcement activities. NCSBN further clarifies that the statutes of limitation in civil and criminal litigation are intended to prevent unreasonable delay and the prosecution of state claims for the purpose of preserving the expectation of private legal rights and that since BONs take disciplinary action in order to protect the public by insuring that only properly qualified and ethical individuals practice nursing, this public safety objective is not time-limited and therefore, statutes of limitations are inapplicable to BON license revocation and other disciplinary proceedings.

The NCSBN further stated that the use of reciprocal discipline also serves to fulfill the legislature's charge to BONs to protect the public and an attempt to evade disciplinary action merely by fleeing the state does not protect the public, therefore, "in the case of reciprocal actions, a state board of nursing is well within its legitimate authority to take action against a licensee on the basis of another state's licensure disciplinary action that implicates the individual's ongoing ability and likelihood to practice professionally and safely."

Continuing Competency Booklet – Status Report on Updates

The EO stated that she is working on amending the booklet to make it more reader friendly and to have a separate section for employers.

Hawaii State Center for Nursing:

Ms. Reichhardt reported the Workforce Report for 2017 will be coming out in November. Some of the findings from the report are as follows:

- APRNs have grown 104% in the last 10 years.
- ➤ Before 2014 54% of new graduates had a BSN or higher.
- ➤ After 2014 72% of the nursing population has a BSN or higher.
- ➤ 81% of nursing population is intending to remain in the workforce.
- ➤ 4% of nursing population is intending to retire in the next 5 years.

The Center is also working to revise its strategic plan. There is a big question about the role of LPNs and how their roles have changed. We also see that LPNs are moving into RN roles very quickly. There is also a need that leadership sees to help staff nurses implement and utilize evidence based practices.

The EO asked Ms. Reichhardt if she is aware of any 2018 legislation?

Ms. Reichhardt replied yes, some topics of interest with the Center are as follows:

- APRN parity; get Medquest reimbursement rates equivalent to physicians.
- Revising the Home Health rules under the Department of Health through legislation.
- Preceptor tax credit bill.

This preceptor tax credit bill would be for APRNs, Dentists, Pharmacists, MDs, and DOs who are doing in-state preceptorships for students. The bill is still being drafted, but it would be between a \$1000 and \$5000 personal income tax credit. They are using a lot of what Maryland, Colorado and Georgia have created since this already passed in those states. She has also heard that the Medical Aid in Dying bill will be returning, but is not sure if APRNs will be included.

The Vice Chair asked if Ms. Reichhardt had any information on nursing graduates here and what percentage are being employed in Hawaii?

Ms. Reichhardt stated they have looked at that but do not have a report on it yet, however, between 15-22% of new graduate nurses between 2014 and 2017 are taking more than a year to get their first job in Hawaii in nursing.

The Vice Chair asked if the Center's reports go out to employers too?

Ms. Reichhardt replied yes.
