New Business:	Point Injection Therapy
	Point of Injection Therapy injects different solutions, such as glucose, saline and herbs with a hypodermic needle into acupuncture points. Injections are subcutaneous. Naturopaths are allowed to do injections. Currently five states allow this procedure performed by licensed acupuncturists.

Dr. Kroll had this procedure done while Dr. Lyftogt was in Hawaii for training. She went through a series of treatments and found it satisfactory and accomplished the results she was seeking. Dr. Tsuchiyama asked whether or not this procedure is covered by malpractice insurance, if schools are incorporating this procedure in their curriculum and if NCCAOM is testing on this topic.

Further research should be done and the Board will discuss at a later date.

Cupping

Cupping is done on acupuncture points. An acupuncture license is needed, which is within the scope of the rules.

Old Business: Proposed Rule Revisions, HAR Title 16, Chap. 72

Subchapter 2

Acupuncture School: institution should be accredited or recognized as a candidate for accreditation to ACAOM.

Functional disorder: delete definition

Traditional Oriental medicine: means the system of the healing art which places the chief emphasis on the flow and balance of energy in the human body as being the most important factor in maintaining the wellbeing of the body in health and disease and includes the practice of acupuncture and herbal medicine.

Subchapter 3

§16-72-4 Authorized practice of acupuncture. An acupuncture practitioner is authorized to treat the human body by stimulating certain acupuncture point or points on the human body to regulate the flow and balance of energy, neurovascular, endocrine and pain pathways in the body. The practice includes cutaneous or invasive stimulation of specific points on the skin with acupuncture needles. Techniques included are acupressure, electrical, mechanical, thermal therapy, moxibustion, cupping, laser acupuncture, lifestyle and dietary consultation and traditional therapeutic means, including prescribing and dispensing herbal medicine.

§16-72-6 Records. Add date/dates treatment was performed and records to be kept on file for at least seven years.
