Email inquiry regarding a journey worker electrician's minimum license requirements for resort/hotel workers. (Deferred at the December 8, 2015 and February 16, 2016 meetings.)

The Board again reviewed the January 13, 2016 letter from James Hardway, Executive Director of Hotel and Restaurant Industry Employment & Training Trust ("HARRIET") concerning union members who would like to eventually advance to positions that require a journey worker electrician or plumber's license as a minimum requirement.

Vice Chairperson Brady stated that journey worker plumbers must have experience in each category unless the residential and commercial experience can be obtained outside of the hotel employment. The Board members did not discuss nor take action on this matter due to loss of quorum. Mr. Hiraki added that all electrical and plumbing work must be performed by a licensed electrician or plumber who can supervise unlicensed workers. DAG Tam stated that the original letter asked how much experience was needed for the scope of work on the experience verification form.

After further discussion, it was moved by Vice Chairperson Brady, seconded by Mr. Lucero and unanimously carried to request more information from Mr. Hardway and to extend an invitation for him to attend the next meeting.

# Chapter 91, HRS Adjudicatory Matters:

Chairperson Akamu called for a recess from the Board's meeting at 11:20 a.m. to discuss and deliberate on the following adjudicatory matter pursuant to HRS Chapter 91.

a) In the Matter of the Plumbers License of DEREK K. AWAYA, Respondent ENP 2013-18-L

SETTLEMENT AGREEMENT PRIOR TO FILING OF PETITION FOR DISCIPLINARY ACTION AND BOARD'S FINAL ORDER.

The Board reviewed the settlement agreement. After discussion, it was moved by Vice Chairperson Brady, seconded by Mr. Hiraki, and unanimously carried to approve the settlement agreement in which:

- (i) Respondent alleges that he was not instructed by his employer to supervise John Lopez, the unlicensed worker, and Respondent did not agree to supervise the unlicensed plumbing work.
- (ii) Respondent states that he satisfied the DUI charge, spent overnight in jail for the theft charge, and paid fines for the traffic violations. Additionally Respondent did not intend to deceive the Board, but he misunderstood the terms "annulled" and "expunged."
- (iii) Respondent agrees that this Settlement Agreement is intended to resolve the issues raised in RICO's investigation in RICO No. ENP 2013-18-L.
- (iv) Administrative Fine. Respondent agrees to pay a fine in the amount of FIVE HUNDRED AND NO/100 U.S. DOLLARS (\$500.00). Payment shall be made by cashier's check or money order made payable to "DCCA – Compliance Resolution Fund" and mailed to the Regulated Industries Complaints Office, Attn: Wendy J. Utsumi, Esq., 235 S. Beretania Street, 9<sup>th</sup> Floor, Honolulu, Hawaii 96813. Payment of the fine shall be due no later than thirty (30) days following the Board approval of this Settlement Agreement.
- b) In the Matter of the Plumbers License of JOSHUA B. CRAIL, Respondent ENP 2013-19-L

SETTLEMENT AGREEMENT PRIOR TO FILING OF PETITION FOR DISCIPLINARY ACTION AND BOARD'S FINAL ORDER.

The Board reviewed the settlement agreement. After discussion, it was moved by Vice Chairperson Brady, seconded by Mr. Hiraki, and unanimously carried to approve the settlement agreement in which:

- (i) Respondent alleges that he was not instructed by his employer to supervise John Lopez, the unlicensed worker, and Respondent did not agree to supervise the unlicensed plumbing work.
- (ii) RICO alleges that Respondent failed to disclose on his journey worker plumber license application that Respondent had been convicted of a driving under the influence on January 23, 2008.
- (iii) Respondent states that he did not intend to deceive the Board, he thought the question about prior convictions was for felonies (not a misdemeanor), and he has not had any other convictions.
- (iii) Respondent agrees that this Settlement Agreement is intended to resolve the issues raised in RICO's investigation in RICO No. ENP 2013-19-L.
- (iv) Administrative Fine. Respondent agrees to pay a fine in the amount of FIVE HUNDRED AND NO/100 U.S. DOLLARS (\$500.00). Payment shall be made by cashier's check or money order made payable to "DCCA – Compliance Resolution Fund" and mailed to the Regulated Industries Complaints Office, Attn: Wendy J. Utsumi, Esq., 235 S. Beretania Street, 9<sup>th</sup> Floor, Honolulu, Hawaii 96813. Payment of the fine shall be due no later than thirty (30) days following the Board approval of this Settlement Agreement.
- c) In the matter of the Plumber's License of WILLIAM V. FERGUSON, JR., Respondent: ENP 2012-32-L

PETITION FOR DISCIPLINARY ACTION AGAINST PLUMBERS LICENSE; DEMAND FOR DISCLOSURE

The Board reviewed the settlement agreement. After discussion, it was moved by Vice Chairperson Brady, seconded by Mr. Hiraki, and unanimously carried to approve the settlement agreement in which:

- (i) On or about September 30, 2015, RICO filed a petition for Disciplinary Action alleging that Respondent violated, in part, the following statute(s) and/or rule(s): Hawaii Revised Statutes ("HRS") § 436B-19(13) (disciplinary action taken in another jurisdiction); and 436B-19(15) (failure to disclose disciplinary action) (hereafter the "Petition").
- (ii) Respondent does not admit to violating any law or rule, but acknowledges that RICO has sufficient cause to file a Petition for Disciplinary Action against Respondent's license.
- (iii) Respondent agrees that this Settlement Agreement is intended to resolve the issues raised in RICO's investigation in RICO Case No. ENP 2012-32-L.
- (iv) Administrative fine. Respondent agrees to pay a fine in the amount of FIVE HUNDRED AND NO/100 U.S. DOLLARS (\$500.00). Payment shall be made by cashier's check or money order made payable to "DCCA – Compliance Resolution Fund" and mailed to the Regulated Industries Complaints Office, Attn: Denise P. Balanay, Esq., 235 S. Beretania Street, 9<sup>th</sup> Floor, Honolulu, Hawaii 96813. Payment of the fine shall be due at the time this Settlement Agreement is returned to RICO.
