## Jason L. Campos, EMT-B

## Charles B. Graves, M.D.

The Board reviewed and considered Dr. Graves request to remove the conditions from his conditional license.

After due consideration of the information received, it was moved by Chair Desai, seconded by Dr. Kosasa, and unanimously carried to remove the conditions placed on Dr. Graves' conditional Hawaii Medical License, License No. MD-16045.

#### Old Business: a. Legislation

### H.B. No. 2335, HD1, SD1, Relating to Physician Discipline

The Board discussed HB2335, H.D.1, S.D.1, Relating to Physician Discipline.

HB 2335, HD1, SD1, authorizes the Board to impose the same disciplinary action against a licensee as was taken by another state or federal agency, establishes conditions for the disciplinary action, and prohibits the licensee from practicing until a final order of discipline is issued if the licensee has been prohibited from practicing in another state.

Executive Officer Quiogue stated that the Hawaii State Legislature's website reflects that the House disagrees with the Senate amendments to the measure.

Dr. Sept asked what the process is if one chamber does not agree with another chamber's amendments.

Executive Officer Quiogue explained that unless both chambers agree on the amendments made to a bill, the bill will be scheduled for conference. She went on to say that during this time, members from the respective committees will be appointed to the conference committee to deliberate over the differences of each measure, and hopefully come to some kind of resolution by way of a conference draft.

#### S.B. 2675, SD1, HD1, Relating to Licensing

The Board discussed SB2675, S.D. 1, H.D. 1, Relating to Licensing.

Executive Officer Quiogue informed members that SB2675, SD1, HD1, was heard by the House Committee on Judiciary, which amended the measure by: 1) specifying that the regulatory boards are not limited to imposing the same disciplinary action on licensees as was imposed by other states or federal agencies; 2) making the measure take effect upon its approval; and 3) making technical, nonsubstantive amendments for clarity, consistency and style.

Executive Officer Quiogue referred to amendment number 1 made by the House Committee on Judiciary, which would allow the respective regulatory boards to take action on a license that is more adverse than the home state's action.

Discussion followed. It was moved by Chair Desai, seconded by Dr. Halford, and unanimously carried to enter into executive session at 1:50 p.m. pursuant to HRS §92-5(a)(4), to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities and liabilities.

It was moved by Dr. Halford, seconded by Dr. Bintliff, and unanimously carried to return to the open meeting at 1:58 p.m.

#### H.B. No. 1708, HD 2, Relating to Medicine & Surgery

The Board discussed HB1708, HD 2, Relating to Medicine and Surgery.

Executive Officer Quiogue reminded members that the House Committee on Consumer Protection passed HB1708 with an H.D. 2, which creates a limited and temporary license for visiting sports team physicians. She went on to say that on March 17, 2016, the Senate Committee on Consumer Protection and Health deferred the measure indefinitely.

Dr. Geimer-Flanders informed members that she and the Executive Officer were instructed to work with the proponents of the measure on legislation for the 2017 session.

Executive Officer Quiogue asked the Board for direction regarding this matter, specifically, its position so that she may begin drafting legislation with the proponents of this measure.

Discussion followed. Members stated that their position remains the same, that sports physicians shall, at a minimum obtain a limited and temporary license as proposed in H.B. 1708, H.D. 2.

It was moved by Chair Desai, seconded by Dr. Geimer-Flanders, and unanimously carried to provide language similar to that of H.B. 1708, H.D. 2, which would require a team physician to obtain a limited and temporary license.

#### H.B. No. 2233, HD 2, SD1, Relating to Health Care Professionals

The Board reviewed HB2233, H.D.2, SD1, Relating to Health Care Professionals.

Executive Officer Quiogue informed the Board that since its last meeting, the House disagreed with the amendments made by the Senate to HB2233, H.D.2, S.D.1. As such, this measure would go to conference.
