Call to Order: There being a quorum present, the meeting was called to order at 10:40 a.m. by Chairperson Galas.

Approval of the Board Minutes: It was moved by Chief Perry, seconded by Mr. Denis, and unanimously carried to approve the Applications Review Committee and Executive Session meeting minutes of the September 15, 2016 meeting and amend the Board meeting minutes as follows:

Mr. Denis wanted to note for the record that the Board's position regarding guard cards for police officers at its June 29, 2016 meeting was based upon HAR chapter 16-97-8; a section created prior to Act 208 (SLH 2010) which only applied to principal guards and detectives as there were no registered guard employees at that time. The Board will revisit this matter in future amendments.

Executive Officer's Report:

- a. Guard Employee Renewals – Audit of Compliance

The Board has received 380 responses out of the 600 audit requests sent on August 31, 2016. a. Initial 8 Hour Security Guard Training Curricula

- 1) Alii Security Systems, Inc. Security Guard 8 Hour Training Program

It was moved by Mr. Chang, seconded by Mr. Denis, and unanimously carried to defer the approval of the Alii Security Systems, Inc. Security Guard 8 Hour Training Program pending an explanation or confirmation of authority to include the Solutions-4-Security's copyrighted curriculum in the submitted program.

The Board discussed whether or not revisions to the 8-hour curriculum should be considered such as the addition of verbal and written communication, report writing and de-escalation. It was suggested that a letter be sent to all curriculum providers to suggest edits to the 8-hour curriculum.

- 2) New Zealand High School Equivalency

The Executive Officer informed the Board that in New Zealand students in the 11<sup>th</sup> and 12<sup>th</sup> year of school take exams in English and math and do not receive diplomas.

The Executive Officer explained that in New Zealand, students are not awarded diplomas or certificates of completion. Students in the 11<sup>th</sup> and 12<sup>th</sup> year are given exams to move on to the next level. Thus passage of the exams are evidence of their completion of "high school". Mr. Chang indicated that he too is aware that students do not receive diplomas as they do in the U.S.

It was moved by Mr. Denis, seconded by Chief Kubojiri, and unanimously carried to accept verification of the examinations given in the 11<sup>th</sup> or 12<sup>th</sup> year from New Zealand schools as equivalent to a U.S. education.
