Chairperson Takeno reiterated that at the Board of Public Accountancy's ("Board") February 5, 2016 meeting, the Board requested that the PROC assist the Board in a review of the peer review process with respect to the Hawaii Supplement to the Peer Review, and to provide comments and guidance as the PROC members may have pertinent peer review experience. The PROC held a meeting on February 25, 2016 and was briefed by ICPR Member Lau with a brief overview, to provide clarification and justification to the Board's request, and at that meeting, the PROC set a tentative meeting to develop illustrative attestation procedures to be performed for firms that are required to submit the Hawaii Supplement to the Peer Review.

Lengthy discussion ensued as to what should be included in the working draft. Chairperson Takeno commented that the PROC is conceptually in agreement as to what it may look like. The PROC in consensus agreed to tentatively set another meeting on May 5, 2016 with a draft of illustrative attestation procedures to be performed for firms that are required to submit the Hawaii Supplement to the Peer Review. Thereafter, the PROC may be able to report its findings to the Board at the Board's scheduled May 6, 2016 meeting.
