a. H.B. No. 235, H.D. 1, S.D. 1, C.D. 1 – Relating to Health, Increases the authorized benefit for acupuncture treatments provided through

motor vehicle insurance.

Executive Officer Kramer asked Dr. Kroll to update the Board on

Dr. Kroll reported that H.B. No. 235 passed through legislature and is with the Governor for signature. H.B. No. 235 would tie in the reimbursement fees for personal injury protection through motor vehicle insurance to the workers compensation fee schedule. Public hearings will be scheduled by the Department of Labor and Industrial Relations. Fee reimbursement for acupuncturists should increase from \$73.88 to \$150.00 per hour. H.B. No. 235 will also affect the Current Procedural Codes used for billing. Currently the codes are listed under surgical incisions and will now be listed under acupuncture codes, which the American Medical Association ("AMA") designed in 2006.

Edits for Subchapter 2 – Definitions

"Accreditation Commission on Acupuncture and Oriental Medicine" or "ACAOM" (means) is an independent accrediting body that is recognized by the United Stated Department of Education ("USDOE") as the entity,

in the United States, that is responsible for accrediting education programs for the preparation of acupuncture and Oriental medicine practitioners and professional post-graduate doctoral programs in acupuncture and in Oriental medicine.

"Acupuncture school" means a college, institute or school that {was} <u>is</u> accredited or recognized as a candidate for accreditation to ACAOM for first professional acupuncture/Oriental medicine and post-professional programs.

"Direct supervision" means that the licensee is physically present during {the} an intern's treatment of a patient {and is treated by the acupuncture intern}. The licensee shall supervise and provide guidance to an intern in the diagnosis and treatment strategy of the patient."
